But he quickly recognized that India's path could not be one of mere replication. The capital intensity—\$10 billion for a 300mm fab—was prohibitive. The talent pipeline was shallow. And the global supply chain was consolidating into oligopolies. Gandhi's breakthrough came through interdisciplinary synthesis. He merged insights

His influence extended beyond policy. In closed-door sessions with industry leaders and academic peers, Gandhi stressed that India's VLSI future required not just capital, but cultural transformation: a shift from imitation to innovation, from siloed expertise to interdisciplinary collaboration. He warned against overreliance on foreign IP, urging the development of indigenous process models—customized for local conditions, like high-humidity environments and grid instability. By the early 2000s, Gandhi's principles had begun to crystallize into a coherent framework. They emphasized modularity in fabrication design—enabling incremental upgrades—and resilience through redundancy in critical steps. But this reliance became a liability during trade tensions: the 2018 U.S. export restrictions on Huawei, the 2022 CHIPS Act limiting advanced chip exports to China, and the broader U.S.-China tech war all revealed how semiconductor scarcity could be weaponized. A nation lacking domestic fabrication capacity was exposed to supply shocks, price volatility, and strategic coercion. Gandhi observed this shift and framed VLSI not as a luxury, but as a pillar of national resilience. He often cited the analogy: 'Just as a country protects its borders, it must secure its silicon. Without control over fabrication, no nation can safeguard its digital destiny.' His advocacy for a multi-pronged strategy—domestic foundry development, strategic partnerships, and process innovation—was rooted in this understanding. Yet the geopolitical context is layered. China's ascendancy in 14nm and below, supported by state-backed

giants like SMIC and YMTC, has set a high benchmark. The U.S., through the CHIPS Act and export controls, has attempted to re-shore advanced manufacturing, but with limited success outside its borders. The EU's €43 billion Chips Act aims to double Europe's share of global semiconductor production by 2030, but faces challenges in talent retention and scale. India, with its demographic dividend and growing tech ecosystem, seeks to carve a niche not through pure capacity, but through strategic differentiation. Gandhi's vision aligns with this approach. He emphasized 'selective integration'—leveraging global foundries (TSMC, Samsung) for access to cutting-edge nodes, while building indigenous capabilities in mid-range and legacy processes where India can compete on cost and skilled labor. This hybrid model avoids the capital intensity of leading-edge fabs while fostering a domestic supply chain. It also allows India to position itself as a reliable partner in global networks, avoiding the pitfalls of technological isolation. But this strategy is not without geopolitical friction. U.S. export controls on EUV lithography and advanced mask tools restrict India's ability to scale 3nm and below independently. China's own self-sufficiency drive, including investments in domestic ASML-compatible lithography, threatens to close global tool markets. Gandhi acknowledges these headwinds: 'No nation is self-contained. Our strength lies in building bridges—through trusted partnerships, shared standards, and multilateral cooperation.' He advocates for a 'tech coalition' approach, where India engages with like-minded democracies—Japan, South Korea, Israel—to co-develop next-generation processes and secure alternative supply chains. This mirrors the QUAD's recent push for semiconductor cooperation, recognizing shared interests in resilient, non-coercive supply chains.
