The 1980s marked the rise of autism parent-led organizations in the U.S. and UK, most notably the Autism Society and later the Autism Society of America's push for the inclusion of autism in the Individuals with Disabilities Education Act (IDEA) of 1990. These movements reframed autism not as a personal tragedy but as a difference requiring systemic accommodation. The 1990s and early 2000s witnessed a critical inflection point: the convergence of neuroscience, genetics, and epidemiology. The Human Genome Project, completed in 2003, opened new pathways to understanding the biological underpinnings of autism. Genome-wide association studies (GWAS) identified hundreds of risk genes, implicating synaptic function, neuronal connectivity, and epigenetic regulation. The discovery of de novo mutations—rare, spontaneous genetic changes—provided a mechanistic explanation for much of autism's heritability, estimated at 50–90% depending on population. The World Health Organization (WHO) estimates that only 10–20% of children with autism in LMICs receive formal support, a gap that reflects not only resource scarcity but also the absence of policy infrastructure. The economic dimension of autism has grown in tandem with its visibility. The global market for autism-related services—diagnostic tools, behavioral therapy, assistive devices, and educational software—has expanded exponentially. In the United States alone, the autism services industry exceeded \$11 billion in 2022, driven by rising prevalence estimates, insurance mandates, and technological innovation. Digital health platforms, AI-driven diagnostic algorithms, and wearable sensors are redefining how autism is assessed and supported. The long-term implications of autism’s global rise are profound. Demographically, with global birth rates and urbanization accelerating, the number of autistic individuals is projected to grow—by some estimates reaching 1 in 60 children by 2030. This demographic shift demands systemic adaptation: education systems must evolve from one-size-fits-all models to flexible, neuro-inclusive frameworks; workplaces must reevaluate hiring practices and accommodations; and societies must confront deep-seated biases about productivity, success, and human worth. (CDC, 2023), exemplifies the institutionalization of autism within public health. The Individuals with Disabilities Education Act (IDEA) mandates free, appropriate public education for autistic children, while the Affordable Care Act expanded coverage for behavioral therapies. Private insurers, though inconsistent, increasingly cover applied behavior analysis (ABA), speech therapy, and occupational interventions. The NIH's Autism Centers of Excellence (ACE) program funds multidisciplinary research across 17 universities, fostering collaboration between geneticists, neuroscientists, and social scientists. Yet disparities persist: Medicaid coverage varies widely, rural areas face severe therapist shortages, and racial minorities are underdiagnosed or misdiagnosed, often due to clinician bias or cultural misunderstandings. In Europe, the European Union's Framework Programmes for Research and Innovation have supported large-scale initiatives like the International Neurodevelopmental Taskforce, which coordinates autism research across 30 countries. The EU's Horizon Europe funding has enabled cross-border studies on early intervention, sensory processing, and digital therapeutics. Countries like the UK and Germany have implemented national autism strategies, integrating healthcare, education, and employment support. However, the EU's decentralized structure results in uneven implementation—Poland and Romania lag behind wealthier members like Sweden and the Netherlands in service access and diagnostic capacity. Asia presents a contrasting landscape. Japan's Ministry of Health, Labour and Welfare has expanded autism support through the "Comprehensive Support for Children with Autism" program, establishing regional centers and training educators. South Korea's government launched a national awareness campaign in 2020, reducing stigma and increasing referrals. Yet in countries like India and Indonesia, autism remains largely invisible—diagnoses are rare, often limited to urban elites, and stigmatization is acute. In China, the government has included autism in the "Special Education Needs" framework, but enforcement varies, and many families rely on informal support networks. The economic burden of autism is substantial and growing. A 2022 study in *The Lancet* estimated the global annual cost of

autism at over \$1.4 trillion, encompassing healthcare, education, lost productivity, and caregiver support. In the U.S., average annual costs per autistic child exceed \$60,000—far above median family income in many states. These figures drive policy: countries with robust early intervention systems report better long-term outcomes and reduced lifelong dependency. Yet cost remains a barrier in LMICs, where one-third of families spend entire incomes on care. The rise of autism as a target market has spurred innovation—and controversy. Tech giants like Microsoft and IBM have invested in AI-driven diagnostic tools and workplace inclusion programs. Startups in Silicon Valley and Tel Aviv develop apps for sensory regulation, social skills training, and communication augmentation. While these tools offer promise, critics warn of digital colonialism—Western-designed technologies imposed without cultural adaptation, or data exploitation in underregulated markets. The “autism tech” industry, valued at \$12 billion in 2023, risks prioritizing scalability over authenticity, reducing lived experience to user metrics. Governments face a dual imperative: invest in evidence-based services while resisting commodification. The World Health Organization’s Global Autism Public Health Initiative (GAP-HI) advocates for equitable access, urging countries to integrate autism into primary care, train local professionals, and combat discrimination. Yet implementation remains uneven. In Nigeria, where autism prevalence may exceed 1 in 100, fewer than 10% of children receive diagnosis or support. In Brazil, recent federal legislation mandates autism services in public schools, but underfunded states struggle to comply. The geopolitical dimension extends to global health diplomacy. Autism has become a proxy in debates over universal health coverage (UHC), with advocacy groups pushing for inclusion in WHO’s UHC monitoring framework. The UN’s Disability Inclusion Strategy (2021–2030) emphasizes autism as a priority, but enforcement depends on national will and resource allocation. As climate change and urbanization reshape migration patterns, autism’s visibility will increasingly intersect with refugee health, urban planning, and digital equity. Looking ahead, the next decade will test whether autism’s global narrative evolves beyond crisis management

toward systemic inclusion. Critics of the neurodiversity movement, including some parents and clinicians, warn that overemphasizing identity risks minimizing suffering, particularly for those with comorbid conditions like severe anxiety, epilepsy, or intellectual disability. The diagnostic expansion has sparked debate within the community itself. In 2023, the Autism Society of America released updated guidelines acknowledging that “Asperger’s syndrome” as a distinct diagnosis is no longer clinically valid, urging clinicians to use the broader autism spectrum framework. This shift reflects a consensus that rigid

subtypes no longer capture the complexity of autistic experience. Yet it has provoked pushback from older advocates who fear erasure of historical identity and lived experience.
