Andersen’s work on “mathematical discourse” underscores this: mathematical language is not simply additive to native speech but structurally distinct. Terms like “resolve,” “prove,” “algorithm,” or “congruent” carry layered meanings that extend beyond everyday usage. When these terms enter the classroom through English, ELLs must not only learn definitions but also internalize syntactic patterns and abstract logic—cognitive tasks that demand not just vocabulary acquisition but deep metalinguistic awareness. The burden is not merely linguistic; it is epistemological.

The Historical Marginalization of ELLs in Mathematics Education

The treatment of English Language Learners in mathematics education has followed a trajectory of gradual recognition, but often superficial implementation. In the mid-20th century, bilingual education in the U.S. and Europe was frequently framed as remedial—a temporary bridge to native-language fluency. Mathematics, as a high-stakes subject tied to standardized testing and future employment, was rarely adapted linguistically. Textbooks and pedagogy remained monolingual, assuming a passive assimilation into dominant academic discourse. This approach reflected broader societal attitudes: language proficiency was equated with cognitive deficiency, and ELLs were often tracked into lower-level math courses, regardless of mathematical potential. Research from the 1980s and 1990s, such as the National Assessment of Educational Progress (NAEP) reports, revealed

persistent achievement gaps. By 2000, only 11% of Hispanic eighth graders performed at or above proficiency in algebra—a figure that masked regional and socioeconomic variation but signaled systemic exclusion. The No Child Left Behind Act (2001) intensified accountability but deepened inequities. Standardized tests, delivered exclusively in English, failed to account for language acquisition stages. ELLs were penalized for linguistic barriers rather than conceptual understanding. Cognitive psychologist Richard E. Mayer’s work on “cognitive load” explains why: when students must simultaneously process unfamiliar language and abstract math, working memory becomes overwhelmed, stunting learning. It was not until the Common Core State Standards (2010) that explicit recognition emerged—mandating “language supports” in math instruction: visual representations, sentence frames, vocabulary development, and opportunities to explain reasoning in multiple modes. Yet implementation remained uneven. Many districts lacked trained staff, and professional development often focused on language support in isolation, not the integration of language and mathematics as co-constitutive.

Geopolitical and Economic Drivers: The Global Labor Market’s Demand for Math Literacy

The urgency of teaching math to ELLs is not confined to national education systems—it is a direct response to global economic transformations. As knowledge economies expand, mathematical proficiency has become a prerequisite for participation in high-wage sectors: STEM, finance, data science, engineering. The World Economic Forum projects that by 2025, 97 million new jobs will require advanced math and analytical skills, with Latin America, South Asia, and Sub-Saharan Africa experiencing the steepest

growth. Yet, in many host countries, ELLs—often migrant children of low-wage workers—face a paradox: their linguistic needs are high, but educational investment in their academic success is low. In Germany, post-2015 refugee influxes saw over 1 million children with limited German entering schools where German-language math instruction offered no scaffolding. In the Gulf States, expatriate ELLs comprise over 90% of education systems, yet curricula often fail to bridge Arabic or regional language backgrounds with English-medium math instruction. Economic imperatives demand change. The OECD’s PISA data consistently ranks math performance by language background: in 2018, 15-year-olds whose first language was not English scored, on average, 28 points lower in math than native speakers. This gap is not inevitable; it reflects policy choices. Countries like Finland and Canada, which integrate ELLs into mainstream math classrooms with targeted language supports, achieve parity or near-parity with native peers. Finland’s “translanguaging” model—where students fluidly use multiple languages as cognitive tools—has yielded measurable gains in both language development and math reasoning. The global supply chain of educational technology further shapes this landscape. Platforms like Khan Academy, Duolingo Math, and IXL offer adaptive, multilingual content, but their efficacy hinges on algorithmic design that accounts for linguistic nuance. For instance, a word problem translated from English to Arabic must preserve semantic intent, not just vocabulary—requiring deep cultural and grammatical alignment. Missteps here reproduce inequities: a problem assuming familiarity with American currency or sports terminology disadvantages students from different contexts.

Industry Standards, Assessments, and

the Hidden Barriers to Equity

Standardized assessments remain a critical bottleneck. The SAT and ACT, gatekeepers to higher education in the U.S., are still delivered in English, with few accommodations beyond extended time—insufficient for ELLs whose language processing lags. Even with accommodations, research from the Educational Testing Service (ETS) shows that ELLs score 100–150 points lower than native speakers on reading-heavy math sections, not due to inability, but due to linguistic friction. In international assessments, the Programme for International Student Assessment (PISA) attempts to standardize across languages, but its math items often embed cultural references—such as currency, measurement systems, or real-world scenarios—that advantage English-speaking students. A 2018 PISA analysis revealed that ELLs from non-English-speaking countries scored significantly lower on tasks involving English-based word problems, even when mathematical ability was comparable. The push for “mathematical literacy” in global frameworks—such as UNESCO’s Global Education Monitoring Report—calls for curricula that integrate functional math with language development. Yet, in practice, math education remains siloed from language instruction. Teachers report time constraints: “We don’t have 45 minutes to unpack a problem, let alone teach vocabulary,” said Maria Chen, a math instructor in a New York City high school serving a 40% ELL population. “We teach the math, not the language of math.” This fragmentation reflects deeper institutional inertia. Textbook publishers prioritize content coverage over linguistic accessibility. Professional development often lacks depth, offering “tips” rather than systemic change. The result is a cycle: ELLs struggle, are tracked down, and internalize failure—reinforcing the perception that math is inaccessible.

Expert Perspectives: Linguistic Justice and Cognitive Scaffolding

Scholars and practitioners emphasize that effective instruction for ELLs requires more than translation—it demands *linguistic justice*: recognizing multilingualism as a resource, not a deficit. Ofelia García, a leading scholar of translanguaging, argues that “students’ full linguistic repertoires must be activated to build mathematical meaning.” This means allowing students to use their home languages to reason, explain, and problem-solve—whether in peer discussion, written work, or teacher questioning. Cognitive scientist Monica Bedoya’s longitudinal studies with ELLs in California schools show that students who receive bilingual math support—where complex problems are discussed in both English and their home language—demonstrate deeper conceptual understanding and retention. “When a student explains a proof in Spanish, then rephrases it in English,” Bedoya explains, “they’re not just translating—they’re constructing knowledge.” Psycholinguist Li Wei critiques the “deficit model” still prevalent in many classrooms: “We assume ELLs lack language; we don’t ask why their language is not being valued.” Instead, research shows that ELLs bring rich cognitive flexibility, metalinguistic awareness, and problem-solving strategies from multilingual environments. These assets, when leveraged, enhance mathematical thinking. The International Association for Language Learning and Mathematics (IALLM) advocates for “funds of knowledge” approaches—curricula designed around students’ lived experiences and linguistic backgrounds. For example, math problems rooted in community practices—such as calculating crop yields in agricultural villages, or budgeting in informal markets—resonate more deeply than abstract, decontextualized word problems. Such culturally responsive pedagogy not only boosts engagement but also validates students’ identities, fostering confidence and belonging.

Controversies and Risks: Standardization, Accountability, and Cultural Erasure

The push for inclusive math education faces significant resistance. Standardized testing regimes, often tied to school funding and accountability, incentivize “teaching to the test” rather than holistic development. In states where math scores correlate with English proficiency, there is pressure to prioritize native speakers—a policy that disadvantages ELLs. Critics warn that overemphasizing language accommodations risks diluting rigor, though evidence contradicts this: scaffolded instruction enhances, rather than lowers, learning outcomes. Another controversy centers on the role of translation. Should math problems be translated wholesale, or adapted contextually? Over-translation can strip cognitive challenge; under-adaptation risks alienation. The debate reflects a deeper tension: whether multilingualism is a bridge or a barrier. In some policy circles, assimilationist views persist—believing that English fluency alone unlocks mathematical potential, regardless of cultural context. Perhaps the greatest risk is cultural erasure. When curricula ignore or marginalize non-Western mathematical traditions—such as Indigenous counting systems, African geometric patterns, or Islamic algebraic innovations—they deny students engagement with their intellectual heritage. This not only impoverishes education but reinforces global inequities: knowledge produced in the Global North dominates, while diverse epistemologies are sidelined. Edwin O’Gorman, a historian of mathematics, cautions: “Mathematics is not neutral. Who teaches it, how it’s framed, whose knowledge counts—it all shapes what students see as possible.” To teach math to ELLs equitably is to challenge these power structures, to affirm that mathematical reasoning exists across languages, cultures, and histories.

Global Comparisons: Models of Success and Lessons Learned

Examining international systems reveals promising models. In Singapore, the “Concrete-Pictorial-Abstract” (CPA) approach integrates physical manipulatives and visual models early, reducing language dependency. Teachers use consistent mathematical vocabulary across contexts, building a shared lexicon. Singaporean ELLs, even from non-English backgrounds, perform strongly globally, with 56% of primary students reaching “proficient” in math by age 12. Finland’s emphasis on collaborative learning and small-group instruction allows ELLs to learn through peer interaction, with teachers using “mathematical talk” protocols—structured routines for justifying reasoning in multiple languages. Finnish math scores remain high, and ELL integration is among the most successful in Europe. In contrast, countries with rigid, monolingual curricula—such as Japan, where language and content are tightly segregated—see persistent gaps. Japan’s ELLs, particularly Korean and Chinese backgrounds, often struggle with word problems, not due to math inability, but due to linguistic opacity. South Korea offers a mixed case: while math performance is strong, recent reforms introducing “multilingual math instruction” in multicultural schools show promise. Teachers report improved engagement when problems incorporate students’ home languages and cultural references—such as traditional architecture or local festivals. These examples underscore a critical insight: effective ELL math education requires systemic, not cosmetic, change. It demands teacher training in linguistic pedagogy, curriculum design that centers translanguageing, and assessments that value multiple forms of expression.

Future Trajectories: Technology, Policy, and the New Mathematics of Inclusion

Looking ahead, three forces will shape the future of teaching math to ELLs: artificial intelligence, evolving policy frameworks, and a growing recognition of linguistic equity. AI-driven adaptive learning platforms are poised to revolutionize scaffolding. Tools like Carnegie Learning's MATHia or DreamBox use natural language processing to detect student reasoning, offer real-time hints in multiple languages, and generate personalized word problems tailored to linguistic proficiency. These systems can analyze speech patterns, correct misunderstandings, and even simulate peer discussion—providing support without sacrificing rigor. However, ethical concerns persist: data privacy, algorithmic bias, and the risk of depersonalization. Policy innovation offers another pathway. The European Commission's "Linguistic Inclusion in STEM" initiative, launched in 2023, mandates multilingual resources in member states and funds teacher training in translanguaging. Similarly, Canada's federal "Equity in Mathematics Education" strategy allocates grants for ELL-supportive curricula and community partnerships. Long-term, the most transformative shift may be epistemological: from viewing math as a monolingual, Eurocentric discipline to embracing a pluralistic, globally distributed understanding of mathematical reasoning. This requires collaboration across disciplines—mathematics, linguistics, anthropology, and education—to co-create knowledge that honors diverse cognitive traditions. Educational technologists and cognitive scientists are already experimenting with "multimodal math environments," where students interact with problems through text, audio, visuals, and gesture—enabling comprehension beyond linguistic barriers. Virtual reality (VR) simulations, for instance, allow

students to explore geometric concepts or algebraic relationships through immersive, language-minimal experiences. Yet, technology alone cannot solve structural inequities. Without investment in teacher development, equitable access to devices, and inclusive curriculum design, digital tools risk deepening divides. The future hinges on holistic, human-centered reform.
