Drawing on psychoanalysis, Marxist critique, and feminist theory, she argued that fatness was not simply a medical condition, but a gendered and classed performance of subjugation. In her seminal works—particularly **Fat Is a Feminist Issue** (1987) and later expanded reflections—Orbach reframed obesity not as a personal failing, but as a symptom of structural violence. She observed that women's bodies, especially those of working-class and marginalized women, bore the brunt of economic precarity, food insecurity, and emotional labor. Fatness, in this context, emerged as both a consequence and a resistance: a corporeal mark of survival under systems that deny agency. For Orbach, the stigma attached to fatness was not natural or inevitable—it was weaponized. It served to discipline women into obedience, reinforcing norms that equated slimness with virtue, productivity, and respectability. This construction was not neutral; it was deeply racialized and classed. Working-class women, disproportionately women of color and migrants, faced compounded scrutiny—labeled not just fat, but unruly, excessive, unfit for respectable society. The evolution of this framework must be understood within the broader geopolitical and economic shifts of the late 20th century. Neoliberalism's rise, beginning in the 1980s, accelerated the medicalization and commodification of fat. As defense budgets were redirected and austerity reshaped public services, health became increasingly individualized. Governments and corporations shifted responsibility for public well-being onto the body itself. Weight loss became a marketable solution—diet culture, pharmaceuticals, bariatric surgery—framing fatness as a problem to be solved, not a variation to be accepted. Orbach's critique gained prescience here: the very systems meant to liberate women through choice instead imposed new forms of coercion. The rhetoric of “empowerment” coexisted with relentless pressure to conform to narrow beauty standards, enforced by media, fashion, and increasingly, surveillance technologies. Biopolitics, a concept pioneered by Michel Foucault, helps unpack this dynamic. In Orbach's analysis, the state and corporate actors jointly regulate populations through management of bodies. Weight control—through diet, exercise, pharmaceuticals—became a mechanism of social control. Public health campaigns, school meal policies, workplace wellness programs, and corporate fitness initiatives all function as instruments of biopower, subtly dictating acceptable bodies. For women, this often meant internalizing surveillance: measuring, tracking, shaming. The result is a paradox: the feminist project of bodily autonomy becomes undermined by the very institutions that claim to support it. Orbach exposed how feminist movements, often focused on workplace equity or reproductive rights, frequently neglected the material realities of weight, reproductive health, and metabolic justice—leaving fat women vulnerable to compound marginalization. The global dimension of this issue reveals stark disparities and contradictions. In high-income Western nations, fatness is pathologized and policed aggressively, often intersecting with racism, ableism, and classism. In contrast, in many Global South contexts, undernutrition and food insecurity persist as primary health crises, yet rising urbanization and Western dietary influences are fueling an epidemic of obesity and related diseases. This dual burden—what scholars call the “double burden of malnutrition”—exposes the unevenness of

globalization's nutritional transition. In sub-Saharan Africa, parts of South Asia, and Indigenous communities in Latin America, fatness is increasingly stigmatized, yet simultaneously linked to poverty, lack of access to healthy food, and historical legacies of colonial food systems. Orbach's framework invites a critical comparison: is fatness policed equally across cultures, or is it weaponized differently within specific socio-political economies? Expert perspectives reinforce Orbach's insight. Dr. Sabrina Strings, a scholar of race, gender, and health, emphasizes that fatphobia is not race-neutral: Black and Brown bodies are disproportionately targeted by both state surveillance and corporate marketing, often framed as "problematic" or "unhealthy." This intersects with historical eugenics and colonial ideologies that linked bodily size to moral and intellectual inferiority. Similarly, Dr. Aubrey Gordon, an anthropologist, documents how fat stigma operates through everyday practices—microaggressions, workplace bias, medical neglect—reinforcing a culture of shame. Economists like Marcia Stepanek highlight how neoliberal health policies incentivize individual responsibility while ignoring structural drivers of obesity, such as food deserts, stress from systemic discrimination, and lack of access to safe spaces for physical activity. These voices converge on a central thesis: fatness is not a personal failure, but a systemic outcome demanding systemic solutions. The pharmaceutical and cosmetic industries have capitalized on this crisis, transforming fat into a market ripe for intervention. The multibillion-dollar weight loss industry—ranging from restrictive diets to GLP-1 receptor agonists like semaglutide—reflects a broader trend: the commercialization of self-optimization. Companies market fat reduction not as health improvement, but as enhancement, success, and control. Orbach anticipated this commodification, warning that medicalization masks deeper social pathologies. When fat is framed as a disease to be cured, the focus shifts from societal change to individual intervention—diverting attention from the root causes: inequality, food injustice, environmental injustice, and psychosocial stress. This pharmacological fixation disproportionately affects women, who are more likely to be prescribed weight-loss drugs and subjected to clinical surveillance. Feminist resistance to this paradigm has taken diverse forms. Grassroots movements, such as the Body Positive and Fat Acceptance Movement, reclaim fatness as a site of pride and political resistance. These movements challenge beauty standards, demand inclusive representation, and advocate for policies that support bodily autonomy—such as workplace protections against weight-based discrimination and equitable access to healthcare. In Latin America, Indigenous and Afro-descendant women's collectives link fat stigma to colonial legacies, asserting cultural sovereignty over bodies and foodways. In Europe, feminist economists and public health advocates push for structural reforms: universal basic income to reduce economic stress, public investment in community kitchens, and regulation of misleading food marketing. These efforts reflect Orbach's call for a feminist politics that centers lived experience, challenges power, and reimagines wellness beyond control. Controversies persist. Critics argue that framing fat as a feminist issue risks reinforcing deterministic narratives—suggesting that fatness itself is the primary site of oppression, obscuring racism, sexism, and classism. Others warn of medical paternalism: while Orbach cautioned against stigma, the risk of neglecting genuine health concerns remains. The debate hinges on distinction: is fat a marker of systemic injustice, or a health variable among many? Orbach's genius lies in refusing binary thinking—fatness is both a lived reality shaped by power, and a site where resistance emerges. To ignore either dimension is to misunderstand. Geopolitical comparisons deepen the analysis. In Scandinavia, where gender equality indices are high, public health policies emphasize body positivity and nutrition education without stigma, supported by robust welfare systems. In contrast, the U.S. and UK exhibit stark disparities: Black and low-income women face higher rates of obesity and discrimination, yet access to effective care remains stratified. In India and parts of Southeast Asia, urbanization drives rising obesity, but traditional food systems are eroded by processed food globalization, creating new forms of metabolic stress. These divergences underscore that fat is not a universal experience, but a culturally mediated one—shaped by history, policy, and power. Looking forward, the long-term implications of Orbach's insight are profound. As climate change intensifies food insecurity and metabolic disease, and as digital surveillance expands bodily monitoring, the politics of fat will only grow more urgent. Artificial intelligence in healthcare may improve personalized nutrition, but also risk reinforcing bias if trained on narrow datasets. The rise of biohacking and genetic testing introduces new ethical frontiers—should fatness be modified, optimized, or accepted? Feminist frameworks demand that such debates center justice: who decides what counts as "healthy," and whose bodies are deemed worthy of care? Strategic insight lies in redefining feminist praxis. It must move beyond symbolic representation to structural transformation—challenging not just beauty norms, but the economic and political systems that produce and police bodies. This requires coalition-building across movements: labor, racial justice, disability rights, and environmentalism. It demands policy innovation—anti-discrimination laws in employment, funding for community health, regulation of predatory marketing. Crucially, it demands narrative change: replacing shame with solidarity, and individual blame with collective responsibility. Orbach's legacy endures because she refused to simplify. Fat is a feminist issue not because it is inherently political, but because the politics of the body—especially for women—are always already feminist. Her work compels us to see beyond the surface of weight, into the systems that shape it, and to recognize that liberation

begins when we stop treating bodies as problems, and start affirming them as sites of power, history, and resistance.

The Biopolitical Grip: Fatness as a Site of State and Corporate Control

Orbach's analysis reveals fatness as a crucial terrain of biopolitical governance—a domain where states and corporations converge to regulate, categorize, and manage populations through bodily norms. Michel Foucault's concept of biopolitics, expanded by scholars like Nikolas Rose and Paul Rabinow, illuminates how modern power increasingly operates not through overt coercion, but through subtle mechanisms of control embedded in institutions, practices, and knowledge. Weight, Orbach argued, became a metric of governance: a quantifiable indicator of discipline, productivity, and moral worth. In the late 20th century, as neoliberalism displaced welfare-state paternalism, health and body size were repackaged as personal responsibility, yet still subject to institutional oversight. Governments, through public health campaigns, school nutrition policies, and workplace wellness programs, promoted weight management as individual choice, even as structural forces—food deserts, economic precarity, environmental toxins—shaped access to health. Pharmaceutical and wellness industries capitalized on this shift, transforming fat into a marketable problem requiring intervention. The rise of anti-obesity drugs, from fen-phen in the 1990s to semaglutide-based therapies today, reflects a broader trend: the medicalization of body size as a disease rather than a natural variation. Orbach anticipated this medical industrial complex, warning that framing fat as a pathological condition shifts focus from systemic inequities to individual behavior. When fat is pathologized, the burden of correction falls on the individual—diet, exercise, pills—while the political economy that produces and exacerbates obesity remains unaddressed. This creates a paradox: while state and corporate actors promote weight loss as a path to health and success, they simultaneously obscure the structural roots of metabolic distress—poverty, racialized food discrimination, environmental degradation, and labor exploitation. The surveillance of fatness extends into digital spaces. Wearable technology, health apps, and corporate wellness programs monitor caloric intake, steps, and heart rates, generating vast datasets used for targeted advertising and insurance risk assessment. Orbach's critique of biopolitical control gains new urgency here: bodies are not only monitored but monetized, with fatness becoming a proxy for risk, inefficiency, and unproductivity. Marginalized women—particularly Black, Indigenous, and migrant women—face compounded surveillance: their bodies are policed by public institutions, commodified by markets, and stigmatized by cultural norms. This intersectionality of oppression reveals fatness as a node in broader systems of power, where gender, race, class, and citizenship converge to shape bodily experience. Reclaiming agency within this framework demands more than personal resistance—it requires structural transformation. Feminist movements must challenge not only beauty standards but the political economy that produces and polices fatness. This includes advocating for universal access to affordable, nutritious food; rejecting weight-based discrimination in employment and housing; and demanding transparency in pharmaceutical and fitness industries. It also means centering the voices of those most affected—low-income women, women of color, disabled women—whose lived experiences reveal the full scope of fatphobia and resilience. The future of this struggle hinges on reimagining wellness beyond control. Orbach's insight invites a feminist ethics of care—one that values bodily autonomy, rejects reductionism, and affirms diversity. In a world where biopolitics increasingly measures worth through metrics of efficiency and appearance, fatness becomes a radical act of presence. To be fat is to resist, to endure, and to reclaim space in a society that would render one invisible. It is a political statement woven into flesh, demanding recognition not as pathology, but as a site of justice.
