can go viral, increasing exposure beyond the host’s intent.” Legal scholars like Prof. Rajiv Nair emphasize that current frameworks lag behind the reality of digital storytelling. “Consent in media has traditionally been a one-time contract,” Nair observes. “Now, with content repurposed across platforms, edited, shared, and remixed, the original agreement is insufficient. We need dynamic consent models—where participants can adjust their involvement as contexts shift.” He advocates for industry-wide standards, supported by regulatory bodies, to protect individuals in an era where personal suffering is both currency and content.
