Moreover, the carbon footprint of transporting materials and maintaining climate-controlled environments undermines conservation goals. Leading institutions now adopt circular practices—reusing materials, sourcing locally, and offsetting emissions—setting precedents for low-impact exhibit design. Long-term, the survival of cheetahs hinges on dioramas evolving beyond spectacle into tools of ecological literacy and policy influence. As climate change accelerates habitat loss, dioramas must incorporate predictive modeling—visualizing corridors for future migration, modeling drought resilience, and illustrating the cascading effects of cheetah decline on ecosystem balance. This shift demands interdisciplinary collaboration: ecologists, data scientists, curators, and local communities must co-create dioramas that are not only visually compelling but scientifically rigorous and ethically grounded.
