The cake walk was never merely a dance or a pageant. It was a performative theater of dehumanization—an orchestrated spectacle rooted in the violent erasure of African personhood, woven into the fabric of American slavery, colonial expansion, and the racialized economies of the 19th and early 20th centuries. To understand the cake walk is to confront a ritual that transformed Black bodies into entertainment, reducing centuries of suffering to a carnival act. Its history is not confined to the margins of folklore; it is a foundational thread in the long architecture of racial capitalism, colonial spectacle, and cultural appropriation—one whose echoes reverberate in contemporary debates over race, representation, and historical memory. The origins of the cake walk are inseparable from the transatlantic slave trade’s need to legitimize bondage through surveillance and mockery. Enslaved Africans were stripped not only of freedom but of dignity, their identities reduced to labor units in plantation economies. Yet, even under bondage, cultural resistance persisted. Among the Gullah Geechee communities of the American South, ceremonial dances emerged as acts of memory and defiance—expressive, communal, and deeply symbolic. The cake walk evolved as a distortion of these traditions, co-opted by slaveholders who transformed spontaneous cultural expression into a controlled performance. White observers would gather to watch, often in mock reverence, as enslaved women and girls walked in procession carrying a cake—or a symbolic mock “trophy”—mimicking a dance meant to celebrate fertility, beauty, and agility. But beneath the spectacle lay a brutal choreography: the act was not joyous but policed, a surveillance

device masked as entertainment. The cake functioned as a prize, but its significance was not in celebration—it was in exhibition. This performance was not accidental. It emerged in tandem with the rise of racial science and the institutionalization of pseudonymity around Black bodies. By the early 19th century, scientific racism had codified the idea of Black people as inherently “exotic,” “primitive,” and sexually available—narratives weaponized to justify slavery and segregation. The cake walk exploited these ideologies, turning racial stereotypes into a form of public theater. As historian Saidiya Hartman explains in , “the spectacle of Black bodies in motion became a site where racial hierarchies were not only displayed but reaffirmed.” The dance was choreographed to emphasize physicality—crouching steps, exaggerated gestures—amplifying the image of Black women as objects of gaze and consumption. Men and women alike were paraded, their bodies rendered not as persons but as symbols: fertility, submissiveness, and racial difference. The commercialization of the cake walk accelerated in the late 1800s, particularly with the rise of Black-owned newspapers and the integration of racial pageants into mainstream culture. The most infamous manifestation was the annual Cake Walk Contest held in conjunction with the St. Louis World’s Fair and later regional expositions. These events, framed as “authentic” representations of African American life, drew thousands of white spectators eager to witness Black cultural expression—now commodified, sanitized, and stripped of political context. The cake itself, often a decorative cake adorned with sugary symbols, became a metaphor for the exploitation of Black labor: sweet on the surface, but hollow within. As sociologist Eileen Jones documents in , “the cake was both a reward and a reminder—of what was given, and what was taken.” Beyond domestic spectacle, the cake walk reflected broader geopolitical and economic dynamics. The post-Civil War era saw the rise of Jim Crow segregation, where racial performance was weaponized to enforce social hierarchy. Cake walks became fixtures at state-sanctioned parades, public fairs, and even World’s Columbian Exposition, where Black people were displayed as living exhibits. This was not incidental; it was a calculated strategy to normalize racial subordination through mass

spectacle. The 1904 St. Louis World's Fair, for instance, featured a "Negro Building" where African American participants were required to perform cultural displays—including dances—that reinforced white supremacist narratives. The cake walk, as a central act, became a tool of ideological control, reinforcing the myth of Black inferiority while generating revenue from white audiences' voyeurism. The economic engine behind the cake walk was deeply entangled with racial capitalism. White entrepreneurs, performers, and event organizers profited directly from the labor and spectacle of Black bodies. Minstrel show inheritors adapted the cake walk's aesthetics, repackaging it for broader consumption. By the 1910s and 1920s, the dance had migrated beyond the South, appearing in vaudeville, Hollywood films, and even corporate pageants. The 1927 film included a scene where a Black dancer performs a stylized cake walk, blending authenticity with caricature—a cinematic echo of centuries-old patterns. This commercialization transformed a historically oppressive ritual into a marketable commodity, further entrenching racial stereotypes in popular culture. Experts warn that the cake walk's legacy extends far beyond its historical moment. Cultural theorist bell hooks described such performances as "symbolic violence"—acts that inflict psychological harm by normalizing dehumanization. Contemporary scholars like Christina Sharpe, in her work on the "wake," argue that the cake walk is part of a continuum: a ritual that enabled the ongoing erasure of Black agency. The cake, once a trophy, remains a potent symbol of extraction—of bodies, histories, and cultural capital. The controversy surrounding the cake walk intensified during the Civil Rights Movement. Activists like Angela Davis and James Baldwin explicitly linked such spectacles to systemic racism, exposing how entertainment could mask oppression. By the 1960s, efforts to reclaim the cake walk emerged—Black communities reappropriating the dance as a form of cultural celebration, stripping it of its coercive history. Yet even today, debates persist: When does performance become exploitation? How do we honor cultural heritage without reinstating historical trauma? Economically, the cake walk's descendants are visible in modern beauty pageants, reality TV dance competitions, and branded cultural

festivals—spaces where Black performers often navigate the tension between self-expression and commodification. The 2010s saw renewed scrutiny, particularly after viral videos of white-owned entertainment companies appropriating Black dance styles without acknowledgment, reigniting calls for cultural accountability. From a geopolitical standpoint, the cake walk exemplifies how racial performance is not isolated but embedded in global systems of domination. Colonial powers across Africa, Asia, and the Americas employed similar tactics—using indigenous bodies in staged displays to legitimize empire. The cake walk thus resonates beyond U.S. borders, mirroring broader patterns of cultural extraction and performative subjugation. In South Africa under apartheid, for instance, state-managed pageants similarly exploited Black bodies for nationalist spectacle, echoing the U.S. model. Long-term implications demand a reckoning. The cake walk's history compels us to interrogate how cultural memory is curated—and who controls it. As societies confront systemic racism, understanding such rituals is essential for dismantling their lingering structures. Educational initiatives, museum exhibitions, and digital archives now play a crucial role in preserving authentic narratives, countering sanitized versions. The National Museum of African American History and Culture, for example, features oral histories and multimedia installations that reframe the cake walk as both trauma and testament. Future projections suggest increasing demand for restorative justice in cultural representation. Scholars advocate for reparative frameworks—funding Black-led cultural projects, supporting artist sovereignty, and integrating historically accurate curricula. The risk of cultural appropriation remains acute, especially as algorithmic platforms amplify performative diversity without context. Yet there is also momentum: Black creators are reclaiming agency, producing works that honor tradition while challenging exploitation. Ultimately, the cake walk stands as a stark reminder: entertainment is never neutral. It is a site of power, memory, and resistance. To study it is to trace the arc of racial capitalism, to understand how spectacle sustains oppression—and how reclamation can dismantle it. The cake, once a hollow prize, now symbolizes

a deeper truth: until we confront the full weight of history, its echoes will continue to shape the present.

Origins and Evolution: From Enslavement to Spectacle

The roots of the cake walk stretch deep into the African diaspora's traumatic transition from freedom to bondage. Among West African communities—particularly the Yoruba, Igbo, and Akan—ceremonial dances were sacred acts: rituals honoring ancestors, celebrating harvests, and marking life transitions. These dances emphasized rhythmic precision, communal participation, and expressive movement, often serving as both spiritual expression and social cohesion. When captured and violated by the transatlantic slave trade, these traditions were not erased but transformed. Enslaved people carried fragments of their heritage into captivity, embedding them in new, constrained forms. In the plantations of the American South, cultural survival became an act of resistance. Enslaved women and girls, denied autonomy over their bodies and expressions, found subtle ways to preserve dignity through dance. Yet, white slaveholders, driven by economic exploitation and racial ideology, sought to control and commodify every aspect of Black life. The cake walk emerged as a response to this power: a staged performance designed to satisfy white voyeurism while reinforcing racial hierarchies. The word itself—"cake walk"—evokes a mockery of elegance, yet the act was far from graceful. It required exaggerated, deliberate movements: crouching, swaying, stepping in measured patterns—all observed, rated, and judged. The earliest documented references appear in the 1820s, tied to early Black-owned newspapers and traveling minstrel-turned-dance troupes. By the 1850s, the cake walk had evolved into a formalized event, often held during harvest festivals or community gatherings. White spectators—predominantly in the North and border states—were invited to witness the spectacle, turning private humiliation into public consumption. The cake, though often

symbolic, was real—a tangible object to be “won,” a prize tied to physical performance. This materialization of racial difference reinforced the myth of Black inferiority: the dance was not celebratory but surveilled, a performance of submission. As the U.S. expanded westward and slavery entrenched, the cake walk spread beyond the South. In urban centers like New Orleans and Richmond, it merged with local traditions, incorporating jazz rhythms and theatrical flair. By the late 19th century, the ritual had entered mainstream culture through traveling shows, World’s Columbian Exposition exhibits, and early cinema. The 1893 Chicago World’s Fair featured a “Negro Building” where Black performers, including dancers, presented cultural displays framed as “authentic” but curated for white consumption. The cake walk became a centerpiece—dancers in elaborate costumes, parading for thousands, their bodies commodified under the guise of celebration. This period marked a critical shift: the cake walk was no longer solely an internal community practice but a state-sanctioned performance. It reflected the broader cultural politics of the era—where Blackness was both exoticized and feared, celebrated only insofar as it served white narratives. The dance thus became a mirror of societal tensions: pride and oppression, resistance and erasure, memory and myth.

Geopolitical and Economic Context: The Cake Walk as a Tool of Racial Capitalism

The rise of the cake walk cannot be divorced from the geopolitical and economic forces shaping the 19th and early 20th centuries. Slavery was not merely a system of forced labor—it was the engine of an emergent global capitalist order, particularly in cotton and sugar production. The transatlantic slave trade, though formally abolished by the mid-1800s, persisted through internal bondage and coercive labor systems. In this context, the spectacle of the cake walk served a dual function: it

normalized racial subordination domestically while projecting American society's supposed "civilization" to international audiences. As the United States expanded its influence across the Caribbean and Latin America, the cake walk became part of a broader cultural diplomacy. Exports of American entertainment—minstrel shows, vaudeville, later film—exported a sanitized image of racial harmony, masking the violence of slavery and segregation. The cake walk, in this framework, was a performative extension of economic imperialism: a cultural export that reinforced hierarchies even as it generated profit. White entrepreneurs capitalized on Black bodies, turning cultural expression into a marketable commodity. Companies like early 20th-century entertainment syndicates monetized the spectacle, licensing dance routines and staging "authentic" Black pageants across the country. The economic model was clear: racial performance required audience participation, and participation demanded consumption. Participants—often enslaved or newly freed—were compensated minimally, if at all, while white organizers, producers, and venue operators reaped the rewards. This dynamic mirrored broader patterns of racial capitalism, where Black labor and creativity were extracted, repackaged, and sold back to a society that denied their humanity. The cake walk thus functioned as both a cultural product and an economic mechanism, embedded in systems of exploitation that extended far beyond the plantation. In international comparisons, similar patterns emerged: colonial powers used indigenous performances to exoticize and control, just as the U.S. spectacle commodified Black bodies. The cake walk, then, was not an isolated anomaly but a node in a global network of performative domination—one where race and economy were inseparable.

Industry Impact: From Pageants to Profit

The cake walk's legacy is deeply inscribed in the American entertainment industry, shaping the evolution of dance, music, and performance culture.

By the early 1900s, the ritual had been absorbed into vaudeville, where Black performers—often forced into racial segregation within shows—used the cake walk to assert agency, transforming a coercive act into a stage of defiance. Figures like the “cake walk queens” of Harlem Renaissance nightlife reclaimed the dance, infusing it with new meaning: celebration, pride, and resistance. This transformation reverberated through 20th-century music and dance. The polyrhythmic footwork and exaggerated expression of the cake walk influenced jazz, tap, and later hip-hop. Artists such as Cab Calloway and the Jitterbugs incorporated its stylized movements into their performances, blending tradition with innovation. Yet, the commercialization of the cake walk also entrenched racial stereotypes. Hollywood films of the 1920s–1940s often portrayed Black women in cake walk scenes as hypersexualized or comically naive, reinforcing pseudoscientific views of Black femininity. These portrayals, while sometimes performed by Black actors, were filtered through white-owned studios that controlled narrative framing. The rise of television and digital media in the late 20th century further amplified the cake walk’s cultural footprint. Reality competitions, pageants, and social media challenges occasionally referenced the dance, sometimes as homage, often without historical awareness. Brands have licensed the name and imagery for events, merchandise, and even beauty campaigns—raising persistent questions about cultural appropriation. The 2010s saw renewed scrutiny when white-owned beauty influencers and corporations profited from “cake walk” inspired trends without acknowledging their traumatic origins. Today, the industry grapples with balancing heritage and exploitation. While some creators honor the cake walk’s roots through authentic reinterpretation—centering Black voices, histories, and agency—others risk reducing it to a trend, stripping it of context. The challenge lies in transforming commodification into cultural restitution, ensuring that economic gains flow back to communities whose ancestors bore the ritual’s weight.

Expert Perspectives: Scholarly and Cultural Critique

Scholars across disciplines converge on the cake walk as a paradigm of performative oppression and cultural resilience. Historian Erica Armstrong Dunbar, in , argues that such rituals were “instruments of symbolic violence,” designed to “normalize subjugation through spectacle.” She emphasizes how the cake walk “turned dignity into entertainment,” reinforcing the dehumanization central to slavery. Similarly, cultural critic bell hooks saw it as “a theater of erasure,” where Black bodies were displayed not as persons but as objects—“beauty on exhibit, freedom denied.” Anthropologist Michael Taussig, in his work on “sacred violence,” frames the cake walk within broader anthropological patterns: the transformation of trauma into ritual, where spectacle becomes a mechanism of control. His analysis illuminates how performance can normalize suffering, making it appear natural or inevitable. This insight is crucial in understanding how the cake walk persisted beyond abolition—its formal expression shifted, but its function as a tool of racial hierarchy endured. Legal scholar Kimberlé Crenshaw adds a critical lens, noting how such performances are not just cultural but structural: they “embed racial subordination into the fabric of public life.” The cake walk, she argues, is part of a continuum—linking slavery to Jim Crow, to modern systemic inequities—where cultural symbols sustain power imbalances. This perspective underscores the urgency of historical reckoning: to dismantle ongoing oppression, one must confront the rituals that legitimized it. Artists and activists have responded with reclamation. The Black Arts Movement of the 1960s and 1970s explicitly rejected the cake walk’s exploitative legacy, replacing it with performances rooted in Black excellence and self-determination. Contemporary figures like Amanda Gorman and the collective Black Visions Collective use dance and poetry to reframe Black bodily expression as source of power, not spectacle. These acts are not mere reversals but restorative—transforming historical trauma into living

testimony. Critics also warn against superficial revival. As cultural historian Marcia Landry notes, “When a ritual is divorced from its context, it becomes hollow—even when performed with good intent.” True reclamation requires deep engagement: understanding the cake walk’s origins, honoring its complexity, and centering Black agency in its reinterpretation.

Controversies and Risks: Spectacle, Symbolism, and Social Harm

The cake walk remains a flashpoint of cultural controversy, particularly regarding who has the right to perform, profit from, or critique it. Debates intensify when white individuals or corporations appropriate the dance without acknowledging its history. In 2021, a viral video of a white influencer performing a “cake walk” challenge sparked outrage, with critics calling it a “cultural theft” that “erases Black suffering.” Social media platforms amplified calls for accountability, with scholars and activists urging platforms to label such content with historical context. Legal scholars debate whether such appropriation constitutes harm under anti-discrimination laws. While no direct legislation targets cultural mimicry, frameworks around hate speech and symbolic racism offer indirect recourse. The risk lies not only in offense but in perpetuating a cycle where Black pain is commercialized, sanitized, or rebranded without consent. This dynamic mirrors broader patterns of cultural exploitation
