Unlike some continental standards that prioritize uniformity, BS 6399:2 retains a pragmatic, context-sensitive approach—acknowledging that London's wind dynamics differ significantly from Edinburgh's or Belfast's. This flexibility has enabled its adoption beyond the UK, particularly in Commonwealth nations with similar maritime exposures.
