AI systems used in social credit and public security remain opaque, justified as essential for stability. F3's demands for auditability clash with Beijing's preference for centralized oversight, limiting cross-border interoperability. Japan and South Korea have adopted hybrid approaches, blending F3 principles with national innovation strategies. Japan's Society 5.0 initiative, for example, ties algorithmic accountability to economic transformation, while South Korea emphasizes AI ethics councils to oversee compliance.
