It is here that Letrs transforms from a curriculum into a professional development engine. The session is

This architecture mirrors the cognitive psychology of expertise development—where deliberate practice, spaced repetition, and contextual feedback are paramount. The evolution of this bridge mechanism reflects a broader shift in global education policy toward competency-based teacher preparation. In the post-PISA era, particularly following the 2009 OECD reports that spotlighted reading disparities, nations began reevaluating how teacher training translates into learning outcomes. Letrs, with its roots in evidence-based linguistics, became a model for bridging theory and practice. Its expansion beyond the U.S.—into Canada, parts of Europe, and emerging economies—has been driven not by exportation, but by adaptation: localized versions now address linguistic diversity, including multilingual classrooms and dialects often marginalized in standardized instruction. The “Bridge to Practice” module, therefore, is not static; it is a living framework, iteratively refined through field testing and cross-cultural validation. Geopolitically, the session’s relevance is amplified by the global crisis in literacy. In contrast, Singapore's system blends strict phonics with rich literary exposure, achieving top PISA scores but with a different philosophical foundation. Letrs, by contrast, offers a middle path: structured yet adaptable, science-backed yet flexible enough to integrate local pedagogies. In post-colonial contexts like South Africa, where language diversity (11 official languages) complicates instruction, Letrs' modular design allows customization without sacrificing rigor—a critical advantage.
