In India, where street-side *chai* stalls dominate, formal testing is rare; skills are passed through generations, emphasizing spontaneity and community trust over standardized exams. Middle Eastern bars, especially in Dubai and Riyadh, emphasize service under pressure—managing large, diverse crowds, navigating cultural norms, and maintaining composure in high-stakes environments. Testing here often includes language proficiency, conflict resolution, and cultural etiquette, underscoring service as a core competency. Meanwhile, Latin American countries like Mexico and Colombia integrate regional spirits—mezcal, pisco, tamarindo—into curricula, testing knowledge of terroir and heritage alongside technique. These differences are not trivial. They reflect how globalization shapes—and is shaped by—local bar cultures. Standardized testing, while promoting mobility and quality, risks imposing Western-centric models on diverse traditions. The challenge lies in designing assessments that honor local knowledge while upholding universal benchmarks of safety, ethics, and craftsmanship.
