The Native American poet Joy Harjo, first Native U.S. Poet Laureate, weaves tribal stories into contemporary verse, reclaiming voice and sovereignty. These diverse expressions challenge monolithic definitions of poetry, demanding frameworks sensitive to cultural specificity while recognizing shared functions: resistance, remembrance, and reimagining.
