In India, where Balakrishnan—born in Kerala in 1949—began her career, colonial-era obstetrics prioritized obstetric obstinacy over gynecologic nuance, reinforcing a hierarchy where female reproductive health was reduced to delivery and maternal survival, with little investment in surgical innovation, hormonal science, or patient-centered care. By the mid-20th century, Indian medical institutions inherited this fragmented model: hospitals specialized in obstetrics but lacked robust gynecologic departments, and clinical training emphasized procedural speed over diagnostic depth or patient autonomy. The result was a system where conditions like endometriosis, cervical cancer, and postpartum hemorrhage were treated reactively, not preventively, and where women’s voices remained marginalized in both research and treatment design. Balakrishnan’s journey—from medical resident in Chennai’s government hospitals to founding director of the Madras Institute of Gynecology and Reproductive Health—was shaped by a growing disillusionment with this status quo. Her early work in the 1980s exposed critical gaps: limited access to laparoscopic techniques, inadequate training in minimally invasive surgery, and a dearth of locally adapted clinical guidelines. These deficits were not merely technical; they were ideological. Dominant gynecologic paradigms, crafted in North American and European academic centers, often failed to account for the biological, cultural, and economic realities of LMICs. In rural India, for example, cervical cancer screening was hindered by lack of infrastructure, stigma, and competing health priorities—yet the global discourse on cervical health remained fixated on Pap smears without context. Balakrishnan recognized that true progress required a textbook that would not only summarize global knowledge but recontextualize it for regional application. The editorial board included feminist scholars, public health epidemiologists, and surgeons trained in both Western and traditional healing systems, ensuring that the text interrogated not just biological facts, but the social determinants of gynecologic health. This pluralist methodology marked a radical departure from the monolithic, paternalistic models of medical authorship. Where earlier gynecologic texts had treated “the female body” as a universal, abstract entity, this textbook emphasized variability—genetic, environmental, and sociopolitical—grounding clinical recommendations in epidemiological data specific to regions like South Asia, where malnutrition, early marriage, and limited sexual education compound gynecologic risk. Geopolitically, the textbook’s emergence coincided with a surge in South-South medical collaboration and a reevaluation of global health governance. The 2010s saw LMICs asserting greater agency: India’s National Health Mission expanded reproductive health services, Brazil’s Unified Health System integrated gynecology into primary care, and Rwanda’s post-

genocide health reforms prioritized maternal and sexual health as pillars of national recovery. The project was partially funded through a consortium of Indian research councils and partnerships with private hospitals in Bangalore and Mumbai, which provided both financial backing and real-world clinical data. This hybrid model—combining public mission with private-sector agility—allowed the textbook to integrate cutting-edge minimally invasive techniques while preserving affordability, with chapters on cost-effective surgical protocols and community-based screening programs tailored to LMIC budgets. Clinically, the \*Textbook\* revolutionized gynecologic education by challenging entrenched hierarchies of evidence. It foregrounded field research from rural clinics and primary care networks, validating community health worker assessments and task-shifting models where nurses manage common conditions like vaginal infections and fibroids. It also introduced frameworks for integrating mental health into gynecologic care—addressing post-traumatic stress in survivors of gender-based violence, a critical but underrecognized component in regions with high prevalence of domestic abuse. In obstetrics, it promoted delayed cord clamping and skin-to-skin care, aligning with WHO guidelines but contextualizing them for settings where traditional practices coexisted with hospital deliveries. Yet, the textbook was not without controversy. Critics within the global gynecologic community raised concerns about the dilution of technical precision in favor of socio-cultural adaptation. Some senior European surgeons dismissed its emphasis on non-surgical management as “clinically insufficient,” arguing it risked delaying necessary interventions in resource-rich settings. Others questioned whether the model of community-driven care could scale in urban centers with fragmented health systems. These debates reflected deeper tensions: the struggle to define “evidence” in medicine—whether it resides solely in randomized controlled trials or must include lived experience and contextual validity. The textbook's response was to champion a hybrid epistemology, where clinical guidelines were not dogma but evolving tools, validated through mixed-methods research across diverse settings. Risks accompanied this innovation. The integration of traditional healing knowledge, while empowering, raised questions about validation and standardization. Could local remedies for vaginal discharge or dysmenorrhea be scientifically vetted without undermining cultural trust? The authors navigated this by establishing a “contextual efficacy” framework—assessing interventions not just by biological outcomes but by acceptability, accessibility, and equity. This approach, though imperfect, set a precedent for decolonizing clinical guidelines, urging practitioners to see communities not as passive recipients but as co-creators of knowledge. Globally, the \*Textbook\*'s impact has been uneven but profound. In Kenya, it became a core curriculum resource for the Kenya Medical Training College, cited in national guidelines on cervical cancer prevention. In Bangladesh, its surgical protocols informed a government initiative to train rural surgeons in laparoscopic myomectomy, reducing patient travel time and mortality. In the UK, despite its origins, it was adopted by teaching hospitals for courses on global



gynecology, challenging Eurocentric curricula with case studies from South Asia and East Africa. Yet, in high-income countries, uptake remained limited—partly due to institutional resistance to redefining expertise, partly due to the textbook’s unapologetic critique of Western medical hegemony. The long-term implications are transformative. This bifurcation created a clinical disconnect—between hospital-based obstetric care and everyday reproductive health needs—perpetuated by a medical hierarchy that equated Western expertise with progress.

Balakrishnan’s early career unfolded amid post-independence India’s push for self-reliance in health. The 1970s saw the launch of the National Family Planning Program, but gynecology remained secondary.

Hospitals were understaffed, surgical training focused on obstetrics, and diagnostic tools—ultrasound, laparoscopy—were scarce outside major cities. When Balakrishnan completed her residency, she observed a critical gap: while obstetric emergencies were managed with skill, chronic conditions like endometriosis, pelvic inflammatory disease, and cervical dysplasia were diagnosed late, if at all. Patients traveled long distances for care, often deterred by cost, stigma, or cultural discomfort with male surgeons. These realities exposed the limits of a model that prioritized acute care over prevention, and obstetrics over gynecology. Her research in Kerala's rural districts revealed a different epidemiological picture. Unlike urban centers, where infectious causes dominated, rural women suffered disproportionately from non-communicable reproductive diseases—linked to early marriage, high parity, and limited nutrition. These patterns were not captured in global guidelines, which often assumed Western lifestyles and healthcare access. Balakrishnan began compiling case studies, interviewing midwives, and analyzing local health data, revealing a clear need for context-specific clinical frameworks.
