Yet Comte's influence was not universal. Across Europe, sociology evolved along divergent paths shaped by local political and intellectual climates. In Britain, thinkers like Herbert Spencer adapted evolutionary theory to social life, framing societies as organisms in constant adaptation—a perspective that justified laissez-faire capitalism while also warning of social decay if progress stalled. Spencer's "survival of the fittest" became a rallying cry for industrial elites, even as critics like Marx challenged its moral neutrality, exposing how such theories obscured systemic exploitation. Meanwhile, in Germany, sociology became entangled with state-building and racial science, as scholars like Ernst Renan and later Friedrich Meinecke debated the role of culture and national identity in an era of unification and militarization. The United States entered the scene later, but with a distinctive pragmatism. Early sociologists such as Lester Frank Ward rejected both Spencer's determinism and Comte's fatalism, arguing instead for human agency and intentional social engineering. Ward's *Dynamic Sociology* (1883) emphasized the power of education, policy, and collective action to reshape society—a perspective that aligned with America's frontier ethos and belief in progress. This American strain, later institutionalized by figures like Robert Park at the University of Chicago, gave rise to urban sociology, focusing on migration, poverty, and racial segregation in rapidly growing cities. Park's work on the "ecology of cities" framed urban life as a complex system of competing groups, laying groundwork for later studies of social stratification and spatial inequality. This geographic and ideological diversity reveals sociology's foundational tension: between universal laws and local specificity, between scientific objectivity and ethical engagement. Talcott Parsons' structural functionalism in the U.S. sought to model society as an interdependent system, a framework embraced by Cold War policymakers seeking stability in a bipolar world. Meanwhile, French thinkers like Pierre Bourdieu critiqued both functionalism and positivism, developing theories of habitus and symbolic violence that exposed how power operates through cultural norms, not just institutions. In Africa, scholars like Samir Amin and Walter Rodney linked sociology to anti-imperialist struggle, arguing that underdevelopment was not a natural state but a product of global capitalist exploitation. Their work reframed development not as a linear march toward Western modernity, but as a contested terrain of resistance and reclamation. The Cold War further complicated sociology's global trajectory. In the U.S., sociology became a proxy battlefield: behavioralism, influenced by psychology and supported by military funding, prioritized measurable outcomes and individual behavior

over structural critique. This shift, while advancing methodological rigor, also narrowed the discipline's scope, sidelining critical perspectives on power and inequality. In contrast, Eastern Bloc countries institutionalized sociology within state-led planning frameworks, emphasizing sociological research that supported socialist reconstruction—though often at the cost of intellectual independence. Post-Cold War globalization intensified these dynamics. The rise of international institutions like the World Bank and IMF promoted “social development” as a universal project, deploying sociological indicators—poverty rates, education access, gender parity—to justify policy interventions. In response, scholars from the Global South advanced alternative paradigms: Latin American dependency theory, which critiqued neocolonial economic structures; African communitarianism, emphasizing ubuntu (“I am because we are”) as a moral foundation for social cohesion; and postcolonial sociology, which interrogated how colonial legacies continue to shape knowledge production and social relations. Today, sociology's global presence is both expansive and uneven. While elite Western universities dominate publishing and citations, digital platforms and transnational networks have enabled scholars from diverse regions to contribute to global discourse. Yet systemic inequities persist: English remains the lingua franca of sociology, marginalizing non-Western languages and frameworks. The dominance of citation indexes and journal prestige can marginalize qualitative, ethnographic, and community-based research—methods central to understanding lived experience.
