Dr. Elena Moreau, a labor scholar at Sciences Po specializing in global logistics, observed: “DHL's 2022 handbook is not just a policy document—it's a narrative of reinvention. It acknowledges that the future of logistics depends not on controlling workers, but on empowering them within a networked, resilient system.”

Controversies and Risks: The Tensions of Compliance and Control Despite its progressive framing, the handbook sparked internal and external scrutiny. Union representatives in Germany raised concerns over expanded digital surveillance, particularly the use of AI-driven performance analytics and

real-time location tracking.
