From the dusty archives of gaming regulators to the boardrooms of global lottery consortia, this framework has emerged as both a diagnostic tool and a geopolitical artifact—revealing the complex interplay between public policy, behavioral economics, and the moral calculus of mass participation in chance-based revenue models. The origins of the assessment questions trace back to the early 2000s, when lottery institutions began shifting from passive

revenue generators to entities expected to demonstrate broader societal value.
