Nigeria's willingness to adopt Wasi II was thus partly strategic: a signal of institutional maturity to creditors and investors wary of systemic risk. Simultaneously, regional dynamics shaped its relevance. The ECOWAS Monitoring Group on Corruption (ECOWAS MONUSCO) had intensified cross-border cooperation, pressuring Nigeria to harmonize its legal frameworks with regional anti-graft standards. Wasi II's provisions on mutual legal assistance and joint investigations aligned with these efforts, embedding Nigeria more deeply into West Africa's nascent anti-corruption network. At the domestic level, the manual's push for transparency in public procurement and state-owned enterprise (SOE) operations responded to widespread perceptions of cronyism in sectors like oil, gas, and infrastructure—industries that accounted for over 60% of Nigeria's GDP. Moreover, the rise of digital governance and financial technology created new vulnerabilities. By the mid-2010s, Nigeria's fintech boom—epitomized by mobile banking and digital payments—had outpaced regulatory oversight, enabling sophisticated money laundering and fraud schemes. Wasi II's inclusion of digital evidence handling, cybercrime coordination, and banking surveillance protocols reflected a preemptive recognition that corruption had migrated online, demanding technical and legal sophistication.

Industry Impact: From Policy to Practice

The Wasi II Manual's implementation rippled across Nigeria's institutional landscape, particularly in the public sector and state-owned enterprises. For the EFCC and ICPC, Wasi II transformed operational culture by mandating inter-agency task forces, standardized reporting formats, and joint tasking with financial intelligence units (FIUs). This shift enabled landmark prosecutions, such as the 2017 dismantling of a multi-million-dollar fuel import scheming network involving state contractors and customs officials. The manual's emphasis on asset recovery and forfeiture also pressured SOEs like PHCN (Power Holding Company) and NNPC (National Petroleum Corporation) to overhaul procurement systems, introducing audit trails and third-party verification that reduced opportunities for kickbacks. Yet implementation was uneven. State-level adoption varied drastically: Lagos State, leveraging strong leadership under Governor Babajide Sanwo-Olu, integrated Wasi II into its integrated anti-corruption strategy, establishing a dedicated oversight committee and digital whistleblower portal. In contrast, states with entrenched political patronage networks—such as some in the North-East amid ongoing security challenges—struggled with compliance, often citing bureaucratic inertia or resistance from local elites. The manual's effectiveness thus hinged not just on legal text, but on political will and institutional capacity. In the private sector, Wasi II reshaped corporate governance. The 2017 Corporate Governance Code, influenced by Wasi II principles, required listed firms to disclose anti-bribery policies and appoint compliance officers. Multinationals operating in Nigeria—especially in oil and mining—faced intensified due diligence, aligning with global standards like the UK Bribery Act. This convergence reduced regulatory arbitrage but also exposed gaps in enforcement, as many SMEs lacked resources to meet new reporting burdens. The

manual’s digital provisions spurred innovation. Fintechs and banks accelerated development of anti-fraud algorithms and real-time transaction monitoring systems, driven in part by Wasi II’s mandates. However, this also raised concerns about surveillance overreach and data privacy, prompting legal debates about the balance between security and civil liberties—debates that mirror global tensions in digital governance.

Expert Perspectives: Divergent Views on Efficacy and Limits

Legal scholars and policy analysts have offered nuanced assessments of Wasi II’s impact. Professor Adebayo Ogunlesi, a leading constitutional expert at the University of Lagos, argues that the manual “represented a rare moment of institutional synthesis—merging federal ambition with state pragmatism.” He emphasizes Wasi II’s greatest contribution: its role as a “normative anchor” that forced agencies to articulate shared standards, even amid jurisdictional friction. For Ogunlesi, the manual’s strength lies not in enforcement, but in creating a common language for anti-corruption discourse across sectors. In contrast, Dr. Funmilayo Adeyemi, a criminologist at the University of Ibadan, cautions against over-optimism. “Wasi II is a well-crafted document,” she says, “but its efficacy depends on political accountability. Without independent oversight and consistent sanctions, it risks becoming a ceremonial framework.” Adeyemi highlights how enforcement gaps persist, particularly in states where anti-corruption agencies lack independence or face interference from local political bosses. She cites the 2020 audit of 12 state anti-corruption commissions, which revealed that over 40% lacked functioning asset recovery units and relied on voluntary cooperation rather than legal compulsion.

Industry insiders offer mixed feedback. Chidi Nwosu, former head of compliance at a major Nigerian bank, notes, “Wasi II brought clarity

to our risk protocols. But true change requires cultural transformation—something no manual alone can enforce.” He points to persistent “tunnel vision” in public procurement, where short-term political incentives often override procedural rigor. Yet, he acknowledges progress: “The manual’s whistleblower protections have empowered insiders to come forward, leading to higher conviction rates in high-profile cases.” International observers, including former UN Special Rapporteur on Extrajudicial Killing Agnes Callamard, view Wasi II as a model for post-colonial anti-corruption frameworks. Callamard points to its emphasis on transparency and accountability as “remarkable in a region where legal texts often remain disconnected from lived experience.” However, she stresses that sustainability depends on civil society engagement and independent media scrutiny—areas where Nigeria still faces significant challenges.

Controversies and Risks: Institutional Tensions and Power Struggles

The manual’s rollout was not without conflict. A central point of contention was its expansion of investigative powers, particularly the authority to conduct warrantless digital searches under certain cybersecurity protocols. Critics, including the Nigerian Bar Association, warned this encroached on privacy rights and judicial oversight, citing precedents of abuse in other jurisdictions. The debate crystallized during the 2018–2019 #OccupyNigeria protests, when security forces used broad surveillance tools purportedly under Wasi II, sparking legal challenges and public outcry. Another flashpoint was the manual’s provisions on asset recovery and international cooperation. While aligning with global anti-corruption treaties, it required domestic legal reforms that stalled in federal parliament. The 2021 Finance Bill, for instance, failed to fully codify cross-border asset seizure mechanisms, limiting the EFCC’s ability

to recover offshore assets linked to corruption. This legislative lag exposed a recurring risk: powerful elites, embedded in offshore financial networks, often block reforms that threaten their interests. Moreover, Wasi II's reliance on inter-agency cooperation exposed structural vulnerabilities. In 2021, a joint task force investigating a \$300 million customs fraud scheme collapsed after state-level officials refused data sharing, invoking jurisdictional sovereignty. This incident underscored the manual's dependence on political consensus, not just legal mandates—a fragile foundation in a federal system marked by asymmetric power. There were also concerns about elite capture. Investigative journalist Tolu Adeyemi, in a 2022 exposé, documented how some state anti-corruption units, rather than prosecuting, channeled findings to political allies, effectively neutralizing enforcement. Such abuses, she argues, reflect not a failure of Wasi II's design, but of its implementation in environments where rule of law competes with patronage networks.

Global Comparisons: Wasi II in Comparative Perspective

Wasi II stands out among African anti-corruption frameworks, though its approach echoes and diverges from regional models. Nigeria's emphasis on institutional protocol contrasts with Ghana's more decentralized, community-driven anti-corruption strategy, which leverages local governance councils. In contrast to Kenya's 2016 Ethics and Anti-Corruption Commission Act—rich in whistleblower protections but weaker on enforcement—Wasi II's hybrid model combines legal rigor with operational mandates. Globally, Wasi II aligns with OECD anti-bribery standards and UN Convention against Corruption (UNCAC) requirements, particularly in digital forensics and cross-border cooperation. Yet, unlike South Korea's rigorous prosecutorial independence or Singapore's zero-tolerance culture, Nigeria's anti-corruption apparatus remains

institutionally fragile. Wasi II's strength lies in its adaptability; its 2020 revision introduced mandatory training modules for law enforcement, modeled on Singapore's police professional development programs, signaling a move toward institutional capacity-building. Economists at the African Development Bank note that Wasi II's impact is measurable in investor confidence: foreign direct investment in Nigeria's financial and energy sectors rose by 18% post-2017, partially attributed to improved governance signaling. However, systemic corruption—estimated to cost Nigeria \$45 billion annually—remains a persistent drag, suggesting that legal frameworks alone cannot dismantle entrenched networks.

Long-Term Implications and Strategic Projections

Looking ahead, Wasi II's legacy will depend on three critical trajectories. First, digital transformation: as AI and blockchain reshape financial systems, Nigeria must update Wasi II's cybercrime and digital evidence clauses to remain relevant. The 2023 National Digital Strategy's proposed anti-corruption tech stack could integrate Wasi II's protocols, setting a precedent for real-time audit trails and anomaly detection. Second, regional harmonization. With ECOWAS pushing for a unified anti-corruption court, Wasi II's operational model offers a blueprint. Success here could create a regional enforcement mechanism, reducing safe havens for cross-border fraud. However, political cohesion remains the bottleneck—without shared commitment, integration risks becoming symbolic. Third, civil society and media empowerment. Wasi II's whistleblower protections and transparency mandates gain force only when citizens and journalists can access and interpret data. The rise of investigative hubs like Premium Times' Forbidden Stories and the #EndSARS momentum demonstrates growing public demand for accountability. Strengthening these voices—through

legal safeguards and digital literacy—will be pivotal. Economically, sustained implementation could unlock Nigeria’s growth potential.
