The legal framework struggles to match the sophistication of modern gangs. Prosecutions rely heavily on anti-gang legislation, such as Queensland’s **Organised Crime and Anti-Money Laundering Act 2017**, which allows enhanced

penalties for gang-related offenses. Yet critics argue these laws risk racial profiling, disproportionately targeting Indigenous Australians and culturally and linguistically diverse (CALD) communities. A 2023 report by the Human Rights Law Centre found that Indigenous youth are 34 times more likely to be arrested for gang-related offenses than non-Indigenous peers, despite similar rates of involvement. This disparity underscores a deeper failure: the criminal justice system often addresses symptoms while neglecting root causes. Community-based interventions offer a counter-narrative. Programs like Melbourne's **Tourtounia** initiative—named after a community leader killed in a gang conflict—focus on youth mentorship, trauma counseling, and alternative pathways. As Dr. Amir Hassan, director of the Australian Institute for Social Justice, observes: 'True prevention requires investment in schools, housing, and mental health—systemic change, not just policing.'
