The proliferation of Spanish-language content online—over 3.2 billion monthly users across platforms—has outpaced traditional lexicographic and grammatical tools. Automated translation systems, voice recognition software, and AI-driven content moderation demand a grammar attuned to colloquial innovation, code-switching, and evolving syntax. Still, its structure reflected a centralized worldview—Madrid as the linguistic center, with peripheral varieties treated as variants rather than co-equal systems. The 21st century disrupted this equilibrium. Demographic shifts—mass migration from Latin America to Europe, internal mobility within Spanish-speaking nations—accelerated linguistic diversification. Others questioned the feasibility of consensus across 20 nations with divergent linguistic priorities. These concerns were valid, but the project’s transparency—open data sharing, iterative drafts, and multilingual peer review—helped build trust. By 2023, after six years of collaboration, the \*Gramática de Referencia del Español Moderno\* emerged. Its creation marks a turning point: from a grammar imposed from above to one co-constructed in dialogue, reflecting the pluralism of a global language in motion.
