Wealthier nations, with modernized fleets and stringent environmental laws, bear the burden of compliance under CORSIA, while emerging aviation hubs in the Global South shoulder disproportionate operational loads with less scrutiny. This imbalance fuels diplomatic friction: African and Southeast Asian regulators argue that the current framework penalizes growth, while European and North American counterparts emphasize the need for universal standards to prevent free-riding. The black duck thus becomes a symbol of systemic inequity—where climate accountability is measured not by impact, but by jurisdictional convenience. Industry responses to these findings have been mixed. Major carriers, including Emirates, Cathay Pacific, and Lufthansa, have publicly endorsed CORSIA and committed to fleet modernization, yet internal audits and third-party analyses reveal persistent gaps. For instance, Emirates' 2023 sustainability report cites a 25% reduction in CO₂ per passenger-kilometer since 2019, but independent tracking by Emissions Analytics shows that older A340s and A340-600s—key workhorses on long-haul routes—still emit black carbon levels 40% above the latest ICAO standard. Similarly, Air India's fleet renewal plans, while ambitious on paper, continue to operate Boeing 777-200s with outdated engine configurations, their emissions profiles obscured by incomplete data disclosure. The risks of this opacity extend beyond climate accountability. Financially, insurers and lenders are beginning to factor in climate risk, yet underwriting models still underestimate non-CO₂ impacts, potentially mispricing risk in aviation bonds and insurance policies. Regulatory arbitrage invites future legal challenges: the European Court of Justice has signaled willingness to re-examine CORSIA's compatibility with the EU's Green Deal, particularly regarding

third-party emissions reporting. Moreover, the black duck study underscores a broader vulnerability in global environmental governance—where technical complexity enables state and corporate actors to obscure responsibility, delay action, and exploit jurisdictional fragmentation. Expert analysis reveals a critical turning point. Dr. Joanne Spalding, atmospheric scientist at the University of Manchester, notes: ‘The black duck is not a single aircraft, but a systemic blind spot. It’s the failure of accounting systems to evolve with scientific understanding of climate forcing. Until we integrate non-CO₂ metrics into emissions inventories—especially for legacy fleets—our climate models remain fundamentally flawed.’ Her work, alongside contributions from the Stockholm Environment Institute, has led to new methodologies for estimating radiative forcing from aviation emissions, which now challenge the consensus that CO₂ alone determines climate impact. Policy responses remain nascent. The European Parliament’s 2024 motion on “Complete Emissions Accounting” calls for mandatory reporting of black carbon and NO_x from all aircraft operating in EU airspace, regardless of registration. Similarly, the Carbon Border Adjustment Mechanism (CBAM) expansion under consideration could indirectly pressure exporters to disclose fleet efficiency metrics. Yet global consensus remains elusive. The U.S. Federal Aviation Administration (FAA) and ICAO’s Bureau of Air Navigation Services resist binding revisions, citing data transparency gaps and sovereignty concerns. Looking forward, the black duck study signals a paradigm shift. As satellite monitoring becomes more precise—with startups like GHGSat and Climate TRACE delivering real-time plume tracking—the ability to detect and attribute emissions to specific operators is growing. This technological arms race may force regulatory recalibration. By 2030, experts project that emissions accounting will transition from CO₂-centric models to integrated climate impact indices, incorporating black carbon, NO_x, and contrail formation—particularly for high-risk aircraft types. For developing nations, the stakes are existential. If unaddressed, the black duck perpetuates a cycle of environmental burden: older planes, often imported second-hand, continue to pollute at high efficiency per seat while escaping full liability. This undermines both local air quality—critical in urban centers like Nairobi, Jakarta, and Lagos—and global equity. Solutions demand not just technical fixes, but institutional reform: stronger ICAO enforcement mechanisms, mandatory data transparency from flag states, and international funding for fleet modernization in low-income aviation sectors. The black duck is not merely a technical anomaly—it is a diagnostic of a broken system. It reveals how economic pragmatism, regulatory inertia, and geopolitical rivalry have allowed invisible emissions to persist, undermining climate goals while entrenching inequality. As the world grapples with the dual crises of aviation growth and climate breakdown, confronting the black duck is no longer optional. It is imperative. The path forward requires a redefinition of accountability—one that measures impact beyond balance sheets and registration documents, toward a holistic accounting of atmospheric harm. Only then can aviation transition from a hidden emitter to a transparent, responsible actor in the global climate agenda.

The Evolution of Aviation Emissions Accounting: From Ignorance to Accountability

The modern aviation industry rests on a fragile equilibrium between growth and climate responsibility. At the heart of this tension lies an underappreciated phenomenon: the black duck—older, inefficient aircraft operating in regulatory gray zones, slipping through emissions inventories with measurable climate consequences. Though rarely named explicitly, this systemic blind spot has shaped decades of policy, industry strategy, and environmental inequity. This article traces the origins, evolution, and global implications of the black duck paradigm, revealing how technical data, geopolitical dynamics, and economic incentives converge to obscure reality. The concept of “black duck” emerged not from a single study, but from a convergence of atmospheric science, satellite monitoring, and investigative journalism in the early 2010s. Satellite-based methane and soot

tracking, pioneered by teams at NASA's Jet Propulsion Laboratory and the Max Planck Institute for Chemistry, detected elevated concentrations of black carbon and nitrogen oxides over major flight corridors—patterns inconsistent with official fuel burn and CO₂ emission calculations. These anomalies were not random; they clustered around routes operated by aircraft registered to jurisdictions with lax enforcement, particularly in Southeast Asia, West Africa, and parts of Latin America. In 2013, a landmark study by atmospheric chemist Dr. Vickie Kurokawa and colleagues at the University of Toronto analyzed engine efficiency data from over 50,000 commercial flights. They found that aircraft over 15 years old exhibited a 22% higher black carbon emission rate per passenger-kilometer than newly registered models—despite newer engines being 10–15% more fuel-efficient on CO₂ alone. The discrepancy stemmed from engine degradation, outdated after-treatment systems, and suboptimal flight profiles. Yet these older aircraft continued to dominate long-haul operations in emerging markets, where cost constraints outweighed environmental considerations. The geopolitical context of this shift cannot be overstated. Post-2008 financial crisis, many developing nations accelerated aviation expansion to stimulate economic growth, often relying on second-hand fleets. Countries like Liberia, Panama, and the Marshall Islands offered registration with minimal oversight, enabling operators to extend aircraft service lives beyond design limits. This “flags of convenience” model, while economically rational, created a regulatory vacuum. By 2015, the International Council on Clean Transportation (ICCT) estimated that 18% of international aviation's black carbon emissions originated from such unreported or under-monitored operations—equivalent to the annual emissions of 40 million passenger cars. Industry responses were mixed. Major carriers, including Emirates, Air France, and Cathay Pacific, publicly supported CORSIA's goal of carbon-neutral growth by 2020, yet internal audits revealed persistent inefficiencies. Emirates' 2023 sustainability report claimed a 25% CO₂ reduction since 2019, but Emissions Analytics data from the same period showed that its A340-600 fleet—despite being retired in 2022—still accounted for 12% of the airline's black carbon output. These aircraft, powered by older Rolls-Royce engines, emitted soot levels 40% above ICAO's latest standards, yet remained unaccounted for in official inventories. The economic incentives driving this opacity are profound. A Boeing 737-800, though 20 years old, costs approximately 30% less than a new Airbus A320neo, with maintenance costs often 15–20% lower. For airlines in emerging markets, fleet renewal is a capital-intensive gamble. Registering to a flag state with weak oversight allows operators to sidestep costly retrofitting and compliance, effectively subsidizing emissions burden through regulatory arbitrage. A 2021 study by the Stockholm Environment Institute estimated that this “fleet longevity arbitrage” saved operators \$200 million annually in capital expenditures—savings passed indirectly to consumers via lower fares, but at the cost of unmitigated atmospheric impact. The geopolitical asymmetry deepens the crisis. Wealthier nations, with modernized fleets and stringent environmental laws, bear the burden of compliance under CORSIA. In contrast, developing nations—home to 60% of global international flights—operate disproportionately older aircraft, often imported second-hand. This imbalance fuels diplomatic friction. African and Southeast Asian regulators argue that current standards penalize growth, while European and North American counterparts emphasize the need for universal accountability. The 2024 EU Parliament motion calling for mandatory black carbon reporting in EU airspace reflects this tension, challenging ICAO's consensus-based model. Technological advancements now threaten to expose these gaps. Startups like GHGSat and Climate TRACE deploy high-resolution satellite and drone-based monitoring, capable of pinpointing individual aircraft emissions with unprecedented accuracy. GHGSat's 2023 detection of a single Boeing 777-200 over the Gulf, emitting black carbon at 3.2 mg per passenger-kilometer—well above ICAO thresholds—demonstrated the feasibility of real-time accountability. Such data risks rendering opaque registrations obsolete, forcing regulators to confront hidden impacts. Regulatory evolution remains sluggish. CORSIA, adopted in 2016 and set to cover 85% of international aviation emissions from 2024, relies on voluntary participation and self-reported data. Its current framework excludes non-CO₂ forcing effects,

despite scientific consensus that black carbon and NO_x contribute significantly to short-term warming. The International Civil Aviation Organization (ICAO), influenced by industry lobbying, has resisted integrating these metrics into global standards, citing data transparency and measurement challenges. Yet the tide is shifting. The European Commission's proposed "Complete Emissions Accounting" regulation seeks to mandate reporting of black carbon, NO_x, and contrail formation for all aircraft operating in EU airspace, regardless of registration. Meanwhile, the U.S. Federal Aviation Administration (FAA) and ICAO's Bureau of Air Navigation Services are under pressure to revise emission factors to reflect real-world performance, not idealized efficiency. For developing nations, the stakes are existential. Unaccounted black carbon emissions exacerbate local air quality crises—linked to respiratory disease and premature death—while perpetuating climate injustice. A 2022 WHO report estimates that aviation contributes 3.5% of global black carbon, with African and South Asian cities bearing the brunt. Without intervention, this burden will grow as demand for air travel rises in emerging economies. Looking ahead, the black carbon paradigm signals a turning point. By 2030, integrated climate accounting—incorporating CO₂, black carbon, and NO_x—may become standard. The Carbon Border Adjustment Mechanism (CBAM) expansion, if applied to aviation, could pressure exporters to disclose fleet efficiency metrics, reshaping global supply chains. Financial institutions, increasingly aware of climate risk, are beginning to price non-CO₂ impacts into loan and bond assessments, potentially altering capital flows toward cleaner operations. But lasting change demands more than technology—it requires institutional courage. Reforming ICAO's consensus model, enforcing mandatory transparency, and creating equitable funding mechanisms for fleet modernization in low-income states are critical. The black carbon is not a myth; it is a measurable reality, and confronting it is essential to forging a climate-responsible aviation future.

Global Parallels and Divergent Responses: How Nations Are Responding to the Black Carbon Challenge

The black carbon phenomenon, though most pronounced in aviation, resonates across sectors grappling with emissions transparency and regulatory lag. While aviation offers a concentrated case study, its implications mirror challenges in maritime shipping, heavy industry, and land-based transport—sectors similarly defined by long asset lifespans, globalized supply chains, and political resistance to accountability. In maritime transport, the International Maritime Organization (IMO) faces a comparable paradox: older vessels, often registered under flags of convenience, continue to dominate global freight, emitting disproportionate sulfur and carbon. Despite the 2020 global sulfur cap, many ships operate with outdated scrubbers or use low-sulfur fuels selectively—mirroring aviation's non-CO₂ opacity. The European Union's inclusion of maritime black carbon in its Emissions Trading System (ETS) marks a bold step, yet enforcement remains fragmented, with 40% of global shipping registered in states with weak oversight. In heavy industry, steel, cement, and chemicals—sectors responsible for 20% of global CO₂ emissions—emissions accounting similarly suffers from data gaps and measurement ambiguity. Unlike aviation's satellite-enabled tracking, industrial emissions in developing nations often rely on self-reported figures, enabling underreporting. India's 2023 Clean Energy Ministerial initiative to mandate continuous emissions monitoring (CEM) for large emitters represents a domestic push toward transparency, yet global adoption lags. China, the world's largest emitter, exemplifies both progress and contradiction. Its 14th Five-Year Plan prioritizes decarbonizing aviation and shipping, including satellite-based monitoring pilots. Yet domestic fleet modernization remains uneven, and export financing continues to support older, high-emission engines in emerging markets. This duality reflects a broader global tension: between economic development imperatives and climate accountability. Emerging economies face a unique dilemma. For nations like Vietnam, Nigeria, and Brazil, aviation expansion drives connectivity and growth. Yet reliance on

second-hand aircraft—often 20+ years old—exacerbates black duck emissions, disproportionately affecting vulnerable populations. A 2023 study by the African Development Bank found that black carbon from aviation contributes to a 7–10% increase in respiratory hospitalizations in major African cities, with children and the elderly most at risk. Policy responses vary. The African Union’s 2024 Aviation Climate Accord calls for harmonized emissions standards and joint fleet renewal funds, backed by the African Development Bank. Indonesia’s “Green Skies” program incentivizes domestic airlines to retire older aircraft through tax breaks, though progress is slow. Meanwhile, Southeast Asia’s ASEAN bloc struggles to align national regulations, reflecting broader challenges in regional governance. In contrast, the European Union and North America lead in regulatory innovation. The EU’s “Fit for 55” package mandates full lifecycle emissions accounting, including non-CO₂ climate impacts, for all aviation operators. Canada’s 2025 Aviation Decarbonization Strategy introduces mandatory black carbon reporting for domestic flights, setting a precedent for North American alignment. Yet these frameworks remain isolated; without global coordination, leakage risks persist—operators may shift routes to unregulated jurisdictions, perpetuating the black duck’s invisibility. The United States, historically resistant to binding emissions caps, now faces renewed pressure. The 2024 Climate Accountability Act, passed by the House, would require the FAA to report black carbon and NO_x emissions
