In the United States, the FDA's cautious stance on botanicals—balancing consumer access with safety—clashed with the Commission's push for harmonized regulation. This interplay revealed a deeper tension: the struggle between national sovereignty over medical traditions and the imperative for global consistency. The Expert Committee's monographs were not neutral dossiers—they were political artifacts. Each entry navigated the fraught terrain between

In contrast, Dr. Amina Diallo, a Senegalese ethnopharmacologist, cautioned: “We must not let Western epistemology overwrite African, Amazonian, or Himalayan knowledge. The monograph must be a tool, not a straitjacket.” Her advocacy for “contextual monographs”—adaptive frameworks that honor traditional use while enforcing safety—gained traction in UNESCO's recent call for pluralistic validation models. Controversies erupted over specific entries. *\*Cannabis sativa\** extracts, long used in traditional medicine, faced stringent limits due to psychoactive risks, despite emerging evidence of therapeutic benefits for neuropathic pain and epilepsy. The Commission's cautious stance reflected risk aversion but frustrated researchers seeking to explore nuanced dosing. Similarly, *\*Echinacea purpurea\**, a mainstay of European herbalism, was restricted to short-term use, limiting claims for chronic immune modulation. These decisions highlighted the tension between precaution and innovation—a recurring theme in regulatory science. Globally, the Commission's influence varied. In Japan, where Kampo medicine is tightly integrated with conventional care, monographs reinforced existing standards without disruption. In Brazil, the Ministry of Health adopted WHO guidelines to regulate *\*Paullinia cupana\** (guarana), boosting export capacity but raising concerns about over-commercialization. In sub-Saharan Africa, where herbal medicine serves 80% of the population, the monographs offered a pathway to formal recognition but exposed gaps in local regulatory infrastructure. Looking ahead, the Commission's long-term impact hinges on implementation. Can low-resource settings build capacity for clinical validation? Will digital tools—blockchain for traceability, AI for phytochemical profiling—enable real-time monitoring and adaptive regulation? The rise of “smart botanicals,” engineered for consistency yet rooted in tradition, may redefine the next generation of herbal medicine. Economically, the trend toward formalization is irreversible. As demand grows, so does pressure on wild plant populations—*\*Taxus brevifolia\** (Pacific yew), source of taxol, faced extinction risks before sustainable cultivation models were adopted.
