This initial exchange planted the first seed: Dilemma was not an individual plot, but a coordinated effort involving technical infrastructure and deliberate misinformation. Becker’s team began cross-referencing the GitHub commit with known intelligence data leaks, discovering a faint correlation between the project’s development timeline and a series of unexplained data breaches at EU media outlets. The name “Dilemma” itself emerged from a leaked internal memo—a project codename possibly chosen for its dual meaning: moral quandary and strategic paradox. It appeared in a footnote referencing a 2018 NATO white paper on “information asymmetric warfare,” where scholars warned that manipulating perception could be more powerful than physical force.
