Parallel developments unfolded in the U.S., where Dr. Alan Scott, an ophthalmologist, adapted the toxin for plagionius brow ptosis, unknowingly initiating the medical repurposing of a neurotoxin. Meanwhile, in South Korea, the convergence of aesthetic medicine and consumer culture accelerated rapidly. By the late 1990s, clinics began offering injectables as elective procedures, catalyzed by a booming youth demographic, rising disposable income, and a cultural shift toward visible self-improvement. The formalization of training emerged not in medical journals alone, but in response to unregulated markets. In Japan, the Ministry of Health mandated standardized certification for injectable procedures by 1995, requiring rigorous clinical rotations and supervised practice. South Korea, despite earlier flexibility, formalized training pathways in the 2000s under the Korean Society of Aesthetic Plastic Surgery (KSAPS), establishing continuing education (CE) credits and ethical codes. In the U.S., the American Society of Aesthetic Plastic Surgeons (ASAPS), founded in 1992, became the primary regulator, introducing mandatory training and credentialing for injectors, though enforcement remains fragmented across states. This divergence—between tightly regulated systems in East Asia and a more diffuse, market-driven approach in the West—reflects deeper cultural and institutional differences. In Japan, medical authority and state oversight dominate; in South Korea, entrepreneurial innovation coexists with professional certification; in the U.S., consumer choice and private sector dynamism define the landscape, often at the expense of uniform standards.

The Geopolitical Economy: A Multi-Billion Dollar Industry Built on Training

In the U.S., independently licensed estheticians charge \$100-\$300 per treatment, but only those with formal training and DEA-compliant credentials achieve sustainable earnings.
