It's a system designed for scarcity, not catastrophe.' Mental health is another critical vulnerability. Idaho ranks 50th nationally in per-capita access to behavioral health services, with rural areas suffering acute shortages. A 2024 survey by the Idaho Mental Health Association found that 63% of rural counties lack a single psychiatrist, and suicide rates have climbed 52% since 2010—mirroring national trends but amplified by isolation and limited support networks.

The collapse of Idaho's timber industry reverberates far beyond employment. Lumber mills once supported entire towns—from supply chains to retail, schools, and healthcare. When Boise's Weyerhaeuser plant closed in 2018, it displaced over 800 workers and triggered a domino effect: local banks tightened lending, small businesses closed, and public services faced cuts. In Pocatello, Idaho's largest Eastern city, a 2021 report by the Idaho Policy Institute documented a 37% drop in property tax revenue tied to mill layoffs, forcing cuts in road

maintenance and emergency response. This economic attrition has reshaped social dynamics. In Coeur d'Alene, a city once known for affluence, homelessness rose by 55% between 2015 and 2023.
