China's Belt and Road Initiative (BRI) offers a contrasting vision: standardized, multilingual labels across Eurasia to streamline trade. The GAF system is integrated into BRI logistics corridors, enabling seamless tracking from Yiwu to Doha. Here, labeling becomes a tool of soft power—facilitating integration while reinforcing China's role as a central node in global supply chains. In authoritarian regimes, labeling controls access. North Korea's postal system uses rigid, state-issued address forms that omit personal names, reducing anonymity and ensuring state visibility. Conversely, in democratic societies, privacy concerns push for minimal labeling—EU postal regulations restrict the inclusion of contact details beyond essential delivery information, balancing efficiency with individual rights.

The economic stakes are immense. A 2021 McKinsey report estimated that inefficient labeling costs global trade \$1.3 trillion annually in delays, re-routing, and administrative overhead. For e-commerce, where customer expectations hinge on speed, incorrect labeling can erode trust—Amazon's 2020 recall of mislabeled international shipments, leading to container seizures and customer litigation, underscores this risk.

Yet labeling also enables inclusion. In sub-Saharan Africa, where formal address systems are lacking, organizations like the World Food Programme use "community-based address systems," assigning unique identifiers to villages and households. These dynamic labels, updated via mobile apps, allow aid to reach even the most remote areas—transforming labeling from a barrier into a bridge.
