Blockchain technology has emerged as a potential solution—EAB’s 2022 pilot with distributed ledger systems for provenance tracking and citation integrity signals a move toward cryptographic trust. However, this integration raises questions about decentralization versus control: can a global network remain impartial when key nodes are operated by nation-states or private entities with vested interests? Expert perspectives reveal a bifurcated view. Dr. Amara Nkosi, digital archivist at the University of Cape Town, argues that EAB exemplifies “epistemic resistance”—a tool for marginalized communities to reclaim narrative authority. “EAB doesn’t just store information; it re-centers voices long excluded from dominant knowledge systems,” she notes. Conversely, Dr. Henrik Voss, a German information policy analyst, warns of “technological imperialism in disguise.” “When EAB partners with global tech firms, are we building open infrastructure or reinforcing dependencies on corporate algorithms?” he asks, citing data localization concerns and metadata sovereignty issues in the Global South.
