When broadcast in neutral Sweden or non-aligned India, these voices became counterpoints to state propaganda, illustrating that truth often lives not in policy papers, but in personal testimony. Economically, the collection’s survival reflected shifting paradigms in media funding. Pre-1950s, radio was largely commercial or public; post-war, state-sponsored and foundation-funded models began to fill gaps in independent journalism. The U.S. National Endowment for the Arts, though established in 1965, had already quietly supported oral history projects by the early 50s. Flanagan’s work, though never funded by NEA, benefited from a broader movement to legitimize non-fiction storytelling as cultural heritage. In Buenos Aires, a 1961 broadcast of a factory worker's story sparked debates in union halls. The voice, rough and unpolished, carried weight because it felt real—unlike the polished diplomats and executives dominating airwaves. Expert observers note that Flanagan's methodology anticipated modern ethnographic journalism. He treated interviewees not as sources, but as co-authors of history. His notebooks, now archived alongside the tapes, contain marginalia not just on content, but on tone, posture, and even the emotional state of the speaker. This attention to nonverbal context was revolutionary: while traditional reporting focused on quotes, Flanagan documented how silence spoke louder than words. A pause wasn't an interruption—it was a moment of reckoning. The industry's response was mixed. Commercial networks dismissed *The Live Collection* as too slow, too unstructured, too human. Yet underground and public radio embraced it.
