It signaled a move from “proof” to “probability,” from “what is” to “what is believed—and why.” Reporters began foregrounding the role of public perception, cognitive bias, and narrative framing in shaping what becomes “real.” This was not relativism, but a

recognition that truth is co-constructed: facts gain weight through consensus, but consensus itself is shaped by belief, context, and access to information. This shift had tangible industry implications. Investigative teams increasingly employed behavioral science to understand how misinformation takes root, designing verification processes that accounted for psychological barriers to belief. Storytelling evolved to not only present evidence, but to invite audiences into the process of belief formation—making the “why you believe” as visible as the “what you know.” Editors began structuring narratives with deliberate epistemic transparency: acknowledging uncertainty, disclosing assumptions, and inviting public scrutiny as part of the verification loop.
