For over a century, the IHO's S-57 standard—formalized in 2000—has governed the exchange of Electronic Navigational Charts (ENCs), defining metadata, coordinate systems, and data hierarchies. Jeppesen, born from the expertise of the Norwegian Maritime Directorate, emerged as the de facto global provider of these ENCs, embedding its charts into the backbone of vessel routing systems, Automatic Identification Systems (AIS), and fleet management software. Over time, Jeppesen's influence extended beyond mere chart provision: it became synonymous with navigational safety, compliance, and operational efficiency. Shipping lines, port authorities, and flag states relied on its data with near-universal trust, its charts encoded in the firmware of navigation systems, the backbones of voyage planning, and the foundation of regulatory reporting. Yet, by the early 2010s, cracks began to appear in Jeppesen's hegemony. The rise of open-source software, growing concerns over data monopolization, and the democratization of geospatial data through satellite imagery and crowdsourced mapping platforms signaled a tectonic shift. In this environment, a new coalition emerged: a consortium of maritime nations including Norway, Singapore, South Korea, and the United Arab Emirates, alongside private innovators and open-data advocates, began developing the Lido Charts. Unlike Jeppesen's closed ecosystem, Lido was conceived as a decentralized, open-access platform that aggregates verified hydrographic data from national agencies, research institutions, and even citizen mariners. For decades, its charts carried implicit Western epistemologies—standardized projections, Eurocentric place names, and routing logic optimized for industrialized shipping lanes. As emerging economies expanded their maritime presence—particularly in the Indo-Pacific, Africa, and the Arctic—calls grew for a cartographic alternative that reflected diverse regional realities. Lido Charts positioned itself as a neutral, multilateral alternative, emphasizing inclusivity and adaptability. Its emergence coincided with broader efforts by BRICS nations and ASEAN states to assert digital sovereignty, challenging the Western-dominated infrastructure of global trade. Port authorities in Singapore and Rotterdam have praised its ability to integrate local bathymetric data, improving berthing efficiency. Yet, industry giants such as Kongsberg, Kongsberg Gruppen (formerly part of Jeppesen's parent DNV), and IBM Marine Solutions have resisted, warning of fragmentation, interoperability risks, and legal liability in a decentralized system. 'A chart is more than a map,' cautioned Dr. Helena Rasmussen, a senior hydrographer at the IHO, 'it's a legal and operational artifact. Introducing multiple, competing standards risks confusion, liability, and a breakdown in the global system's coherence.' Regulatory bodies stand at a crossroads. The IMO, while endorsing open standards in principle, remains cautious, emphasizing the need for global harmonization and rigorous validation. The International Hydrographic Bureau (IHB) has initiated consultations on Lido's governance model, seeking to determine whether a decentralized cartographic system can meet the safety and legal requirements enshrined in SOLAS (Safety of Life at Sea). Meanwhile, classification societies like DNV face internal tension: Lido offers innovation and market relevance, but jeopardizes their core business. DNV's 2023 strategic review acknowledged the 'existential ambiguity' of their role—gatekeeper of maritime data or facilitator of open systems? Expert analysis reveals a deeper tension: the shift from cartographic authority as control to authority as transparency. In the Jeppesen era, trust was rooted in institutional pedigree—hydrographic offices' decades of peer review, standardized certification, and liability frameworks. Lido challenges this by decentralizing trust through open-source validation, community oversight, and algorithmic accountability. This mirrors broader trends in digital governance, from open government data to blockchain-based identity systems. Yet, trust remains fragile. As Dr. Marcus Lin, a maritime geographer at the University of Malaya, observes, 'Open data is not inherently transparent. Without mechanisms to verify accuracy, authenticity, and provenance, it risks becoming a labyrinth of unreliable information. Lido's success depends not just on technology, but on building a culture of shared responsibility.' The risks of this transition are real. Fragmentation

of navigational data could increase the likelihood of maritime incidents, particularly in high-stakes corridors. Cybersecurity vulnerabilities rise when data flows across decentralized nodes. Legal jurisdiction becomes murky when a chart's source is unclear. Worse, geopolitical actors may exploit Lido's openness to disseminate disinformation or advance territorial claims—imagine a contested archipelago rendered with competing Lido datasets, each reflecting a nation's narrative. The 2022 South China Sea incident, where conflicting digital charts were cited in diplomatic disputes, foreshadowed such dangers. Yet, the long-term implications suggest a transformative shift. If Lido gains sufficient traction, it could catalyze a new paradigm: a polycentric cartographic ecosystem where multiple authoritative systems coexist, each serving distinct functional or political needs.
