In low-resource settings, damaged containers or improper storage often render solutions ineffective before use. Recent regulations mandate safer handling in industrial facilities and restrict chlorine discharge into waterways, pushing manufacturers toward closed-loop production systems and waste recovery.

Long-Term Implications and Strategic Futures
