The 1960s Thalidomide tragedy—though originating in West Germany—sent shockwaves through the UK, exposing critical gaps in international regulatory coordination and catalyzing a rethinking of drug safety governance. Dale and Appelbes emerged formally in 1973 as the culmination of a parliamentary initiative to centralize and strengthen regulatory authority.
