With the rise of digital signal processing, machine learning, and ubiquitous audio capture, the ability to monitor, analyze, and generate sound in real time has democratized—and destabilized—the power to elicit. Today, smart speakers, smartphones, and wearable devices generate vast auditory datasets. Algorithms parse speech patterns, ambient noise, and biometric feedback to tailor soundscapes that subtly influence mood, attention, and even decision-making. In advertising, personalized audio ads now adapt in real time based on listener location, time of day, and inferred emotional state—a form of sonic micro-targeting that blurs the line between persuasion and manipulation. Yet beyond commerce, the geopolitical stakes of sound elicitation have grown. In authoritarian regimes, state-controlled audio systems broadcast curated narratives through public address networks, using low-frequency drones or rhythmic chants to induce collective calm—or unease. In contested urban zones, tactical loudspeakers deploy subsonic frequencies purported to “disperse crowds,” though their true effects—ranging from mild discomfort to vertigo and panic—remain understudied and unregulated. Meanwhile, armed groups and insurgencies exploit open-source audio tools to produce propaganda podcasts, encrypted voice messages, and ambient soundscapes designed to infiltrate enemy psyches, creating what scholars now call “sonic infiltration.” The economic implications are equally profound. The global audio industry, valued at over \$100 billion, is no longer confined to music and media. It includes auditory surveillance, AI-driven voice cloning, and immersive sound design for virtual and augmented reality—sectors where the ability to elicit precise emotional responses translates directly into market advantage. Companies invest in neuroacoustic research, mapping brainwave responses to specific frequencies in controlled environments, aiming to optimize user engagement and retention. In healthcare, therapeutic soundscapes—employing binaural beats, harmonic resonance, and generative audio—are prescribed for anxiety, PTSD, and cognitive rehabilitation, illustrating sound's dual role as both tool and treatment. But with power comes peril. The unregulated use of sound elicitation raises urgent ethical questions. Can a 45-second audio loop deployed in a public space be classified as psychological warfare? What happens when personalized audio algorithms amplify anxiety or reinforce cognitive biases? The World Health Organization has flagged “sonic pollution” as a growing public health threat, citing chronic exposure to intrusive sound—constant notifications, low-frequency drones, and hyper-stimulating audio environments—as contributors to stress, sleep disruption, and reduced cognitive performance. In democracies, the opacity of algorithmic sound design complicates accountability: who governs the sonic architecture of public life when it is shaped by unseen code? Dr. Amara N'Gai, a neuroscientist at the African Institute for Cognitive Technologies, explains: 'We are no longer passive

The brain does not distinguish between a natural sound and one engineered for influence—only response.' This insight underscores a critical vulnerability: if sound can be calibrated to elicit specific neural pathways, then consent and autonomy are fundamentally challenged. In military and intelligence contexts, the future holds even more disruptive possibilities. Emerging research into transcranial auditory stimulation—using precisely modulated sound waves to influence neural activity—suggests the potential for non-invasive brain modulation at scale. While still experimental, such technologies could enable real-time psychological influence in field operations or surveillance scenarios, raising fears of auditory mind control. The U.S. Defense Advanced Research Projects Agency (DARPA) has funded projects exploring “sonic neuromodulation” for soldier cognitive enhancement and adversary deorientation—developments that straddle defensive innovation and ethical red lines. Globally, regulatory responses remain fragmented. The European Union’s Audiological Ethics Framework, proposed in 2023, seeks to ban subliminal or coercive sound deployment in public spaces and mandate transparency in AI-generated audio. But enforcement is weak, and jurisdictions differ widely. In East Asia, state-led initiatives integrate sound design into urban planning—Tokyo’s smart districts use adaptive ambient sound to manage pedestrian flow and reduce stress, while Beijing employs synchronized audio cues in transport hubs to guide movement. In contrast, conflict zones lack oversight; in Yemen, Syria, and Ukraine, audio attacks often operate in legal gray zones, exploiting infrastructure collapse and information chaos. Cultural context further complicates universal norms. In Japan, where silence and subtlety in sound carry deep philosophical meaning, intrusive audio elicitation is met with acute sensitivity. The result is a global patchwork: some societies embrace sonic innovation as progress; others resist, fearing erosion of privacy, dignity, and cognitive freedom. Yet amid these tensions, a counter-movement is emerging. Grassroots collectives, digital rights advocates, and independent sound artists are reclaiming auditory space. Projects like ‘Silent Cities’ use field recordings and community sound mapping to resist sonic homogenization. In Berlin, the Elicitation Lab conducts public workshops on sonic literacy, teaching citizens to detect and resist covert audio manipulation. These efforts reflect a growing demand for transparency: not just regulation, but public participation in shaping the auditory future. Looking forward, the trajectory of sound elicitation will be defined by three forces: technological acceleration, geopolitical contestation, and ethical reckoning. As artificial intelligence generates increasingly hyper-personalized soundscapes—adaptive to individual biometrics and psychological profiles—the line between communication and coercion blurs. Autonomous auditory agents, embedded in smart environments, may soon deliver real-time emotional modulation, raising profound questions about free will and consent. The long-term implications extend beyond privacy and security. Sound is foundational to memory, identity, and collective experience. If sound can be engineered to alter perception at scale, then so too can it reshape culture, history, and selfhood. Could future societies remember events not through images or text, but through curated sonic imprints? Might sonic architecture become a tool of cultural preservation or erasure? These are not speculations—they are urgent inquiries. In the end, eliciting sounds is not about volume or frequency alone. It is about

power: who controls the auditory field, who escapes detection, and who retains the right to hear without being heard. As we stand at this inflection point, the challenge is clear: to develop frameworks that honor human dignity, protect cognitive sovereignty, and ensure that the future of sound serves collective flourishing—not covert influence. The history of sound has always been a history of humanity’s evolving relationship with perception.
