Yet this U.S.-centric dominance raises questions about global equity. In Latin America, scouts and analysts often bridge Western metrics with indigenous knowledge. Young Venezuelan coaches, trained in both local instinct and global data models, exemplify this synthesis. They track spin rates and launch angles but also observe how players read pitchers, adapt to pressure, and perform in high-stakes environments—recognizing that the stat sheet measures performance, not potential fully. The tension between these viewpoints is not merely academic—it plays out in real-time, influencing how teams build rosters, develop players, and engage with fans.
