clarity. Without these, its actions risk undermining the very security it seeks to provide.” This sentiment resonates across academic and policy circles. The CID’s *modus operandi*—often shrouded in confidentiality—has long been justified by operational necessity, yet public trust remains fragile. Recent parliamentary reports, including the 2023 **Informe de la Comisión de Control Parlamentario**, highlight recurring concerns: insufficient parliamentary oversight, inconsistent internal audits, and limited mechanisms for redress when abuses occur. These gaps feed a narrative of opacity that undermines public confidence, particularly in communities subjected to surveillance or law enforcement action. In response, a series of reform initiatives have emerged. The 2022 **Ley de Inteligencia y Seguridad** introduced new parliamentary committees with enhanced investigative powers, mandatory annual public reporting, and stricter protocols for surveillance warrants. Additionally, the CID has established a formal **Oficina de Derechos Humanos**—a rare internal body tasked with reviewing cases involving civil liberties. While early assessments suggest incremental progress, independent watchdogs remain cautious. “These reforms are steps forward,” notes Dr. Elena Martínez, “but true accountability demands structural independence—free from political interference and insulated by robust whistleblower protections.” Beyond Spain, comparative analysis reveals instructive parallels. The UK’s Investigatory Powers Tribunal and Germany’s Federal Commissioner for Data Protection offer models for balancing oversight and operational efficacy. But Spain’s hybrid political landscape—marked by regional tensions and fragmented governance—complicates uniform implementation. The CID’s future, therefore, depends not only on legal frameworks but on cultural transformation: fostering a professional ethos grounded in ethical restraint, public engagement, and institutional humility.

Controversies and Risks: Surveillance, Power, and Democratic Erosion

The CID’s expanding surveillance and investigative powers place it at the heart of one of democracy’s most enduring dilemmas: how to protect citizens without endangering their freedoms. Though the agency claimed the data was anonymized and used solely for criminal investigations, independent forensic audits confirmed vulnerabilities to misuse and unauthorized access. Such incidents underscore a deeper risk: the normalization of intrusive surveillance under the guise of national security. The CID’s legal authority to conduct “preemptive” investigations—based on behavioral

indicators rather than proven acts—blurs the line between prevention and presumption. This practice, while effective in certain contexts, challenges core democratic principles enshrined in the Spanish Constitution and international human rights law.
