Authoritarian regimes have long weaponized state media to project legitimacy, but democratic societies face their own dilemmas: how to protect independent journalism while countering manipulation by bad-faith actors.

For journalists positioned “at the top,” visibility becomes a strategic asset. They are not just reporters—they are interpreters, often serving as the primary lens through which audiences understand complex political and economic realities. This is particularly evident in Latin America, where investigative reporting has repeatedly exposed corruption scandals implicating presidents, judges, and business elites. The 2015 “Panama Papers” investigation, coordinated by ICIJ, exemplified this dynamic: journalists across 80 countries, including key contributors from Latin America, published stories that implicated regional leaders, triggering mass protests and legal reforms. The journalists involved became global figures, their presence “at the top” of a transnational effort to uncover hidden power. Yet this visibility also invites counter-narratives.

Governments, especially those with weak democratic institutions, frequently deploy smear campaigns, surveillance, and legal pressure to discredit critical voices. In Mexico, for instance, journalists who rise to prominence often face threats, intimidation, or even murder. The case of Javier Valdez, founder of **Ríodoce**, who was assassinated in 2017 while investigating drug cartel violence, underscores the peril. His visibility had made him a target—but also a symbol of resistance. Globally, comparisons reveal divergent models. In Scandinavia, public service broadcasting maintains high trust, with journalists respected for impartiality rather than spectacle. In contrast, in countries like Hungary or Turkey, media visibility is constrained by state control or coercion, limiting the rise of independent “top” figures. The phrase “te veo en la cima,” therefore, carries different weight depending on context: in open societies, it signifies accountability; in closed regimes, it may denote danger or defiance.

Economic Realities: The Cost of Visibility

In Mexico, for example, over 70% of investigative reporters work on freelance or part-time arrangements, lacking the stability to pursue long-term projects. The digital age has introduced new funding models—crowdfunding, nonprofit journalism, and international partnerships—that help sustain high-impact reporting. Outlets like *El Faro* in El Salvador and *La Silla Vacía* in Colombia exemplify this shift, combining rigorous reporting with diversified revenue streams. These organizations recognize that visibility, when paired with credibility, can attract both readers and donors. Yet scalability remains a challenge. Most independent investigative units operate at a fraction of the size of major media conglomerates, limiting their reach. Moreover, the concentration of digital platforms—where attention is monetized—exacerbates inequality. A single viral moment can catapult a journalist to global prominence, but only if algorithms favor their content. This creates a winner-takes-all dynamic, where a handful of voices dominate visibility, while others remain marginalized. The phrase “te veo en la cima” thus risks reinforcing existing power imbalances unless deliberate efforts are made to democratize access and amplify diverse perspectives.

Expert Perspectives: The Dual Role of the Journalist at the Top

Her visibility, he notes, was both a shield and a burden. Yet experts caution against romanticizing the role. The psychological toll—trauma, burnout, and isolation—is well-documented. In high-risk regions, journalists often lack institutional support for mental health. Furthermore, the cult of individual prominence can overshadow collective efforts, fragmenting the very movements investigative reporting seeks to empower. As Dr. Ríos warns, “When we elevate one person as ‘the top,’ we risk ignoring the hundreds of researchers, editors, and sources who make the work possible.”

Controversies and Risks: The Peril of Visibility

The ascent to “the top” is rarely uncontested. In many countries, journalists who expose power face coordinated backlash—from smear campaigns and legal harassment to physical violence. The 2023 murder of Brazilian journalist Dom Phillips and Indigenous rights defender Bruno Pereira, whose reporting on illegal logging in the Amazon had made them targets, shocked the global media community. Their deaths underscored the lethal risks of investigative work, particularly in regions where environmental and political interests collide.

In Mexico, the National Institute of Statistics and Geography (INEGI) reports that over 40 journalists were displaced or threatened between 2020 and 2023, many due to their investigative focus. The Committee to Protect Journalists (CPJ) notes that impunity remains rampant—few perpetrators are punished, reinforcing a climate of fear. For “top” journalists, visibility is both a shield and a target
