Early pilot studies at King’s College London demonstrated a 27% average increase in aerobic capacity among middle-aged participants with sedentary lifestyles, with no reported overtraining. Yet the plan’s commercial breakthrough came not from clinical validation alone, but from a strategic alignment with global economic trends. The post-2020 wellness economy, valued at \$1.5 trillion, was already saturated with apps and wearables, but lacked

In India, where urbanization and sedentary lifestyles fuel rising diabetes rates, startups like FitIndus have localized the model, integrating Ayurvedic recovery principles and vernacular coaching. This hybrid approach, blending Western HIIT with traditional wellness, has gained traction in tier-2 cities, illustrating how global protocols are reshaped through cultural lensing. In contrast, Scandinavian countries—renowned for egalitarian healthcare—have approached Murph cautiously.
