The breach, later traced to a compromised cloud service used by multiple newsrooms, exposed sensitive source material and personal data—including locations of confidential informants. The incident prompted a global reckoning on digital security in journalism, leading *TerraVeritas* to develop a proprietary encryption protocol adopted by over a dozen outlets. Rebecca’s legacy is not merely in the scoops—though her 2022 investigation into foreign interference in Latin American democracies, which traced over \$800 million in undisclosed political funding through cryptocurrency, remains a landmark. It lies in her systemic impact: shaping a generation’s understanding of journalism as a public good, embedding transparency into newsroom culture, and redefining investigative practice in the digital era. Her methodology—blending archival rigor with digital forensics, contextual depth with audience engagement—has become a
