realism limits imaginative possibility in an age demanding new forms of hope. In response, Yu Hua has emphasized that his task is not to offer solutions but to bear witness—“to show what was, so we do not forget.” This stance aligns with a broader tradition of dissident literature that values truth-telling over redemption. His influence extends beyond literature into film, philosophy, and public discourse.
