This technique, developed over years of journalistic rigor, reflects Joyce's dual formation: trained as a journalist in the precise, factual mode of the late Victorian press, yet haunted by the Romantic and Modernist currents that rejected empiricism in favor of inner experience. His Dublin Times editorials had taught him clarity, but his immersion in Irish literary circles—with figures like Yeats and Synge—urged him toward interiority. The portrait thus becomes a battleground between external reality and internal myth. It is a testament to the resilience of the human spirit, not through grand gestures, but through the quiet, relentless act of seeing—to look inward, to name the ineffable, to become art.
