The Johannine community, likely composed of displaced or marginalized Jews and Gentiles, found in John's emphasis on internal spiritual transformation and communal witness a framework for survival and identity formation. The recurring themes of light, truth, and life (John 8:12; 12:35–36) function not only as theological affirmations but as economic metaphors: light as clarity in a corrupt marketplace, truth as stable value in a deceptive economy. This symbolic economy resonated deeply in a world where reputation, trust, and access to resources were tightly bound to social and religious conformity. The rise of Christianity under imperial patronage—culminating in Constantine's Edict of Milan (313 CE) and later Theodosius's establishment of Christianity as state religion—marked a dramatic shift in the Gospel's reception. Yet the original context remained potent. The Johannine Gospel, with its suspicion of institutional power and emphasis on personal testimony, subtly critiques the very structures that would later absorb and reshape Christian identity. This tension—between radical discipleship and institutional authority—continues to animate debates over the Gospel's meaning, particularly in contexts of political resistance and religious pluralism.
