The Vietnam War, Watergate, the Cold War's proxy conflicts, and the rise of state surveillance apparatuses created an environment where investigative journalism became both more vital—and more perilous. Sumrall's emphasis on cross-referencing and contextual depth emerged as a direct response to an era of manufactured uncertainty, where governments and corporations deployed disinformation to legitimize intervention, suppress dissent,

or obscure malfeasance.
