South Korea's response was both pragmatic and visionary. The KTEA framework emerged at a moment when Seoul sought to redefine its global economic role—not merely as a manufacturing hub, but as a standard-setter. This model attracted interest from African and Latin American nations seeking to strengthen domestic capital markets without full integration into Western-dominated institutions. Yet this rise was not

without friction. Critics argued that KTEA's opaque scoring logic—its “black box” algorithm—undermined accountability.
