But the scandal was more than reputational. It exposed structural vulnerabilities in Romig's own model. The memo's existence revealed a critical gap: while her networks excelled at consensus-building, they lacked transparent mechanisms for public oversight. In an era of hyper-scrutiny, where digital archives and whistleblower platforms amplify accountability, the very flexibility Romig had exploited became a liability.
