A 2021 study at a Canadian nursing school found that non-native speakers scored 15% lower on automated sections despite equivalent clinical knowledge, highlighting a systemic inequity. Furthermore, the bank's reliance on data-driven feedback risks reducing nursing—a deeply humanistic profession—to quantifiable metrics. Clinical judgment, by its nature, involves empathy, cultural sensitivity, and moral reasoning—qualities difficult to operationalize. The test bank's strength lies in measuring pattern
