Security researcher and protocol architect Dr. Sarah T. Hansen points to a critical blind spot: protocol resilience against emerging threats. In a 2023 keynote at DEF CON, she highlighted how legacy protocols like SNMP and FTP, still widely used, lack modern security mechanisms, making them prime targets for exploitation. She advocates for a 'security-by-design' approach, where protocols are built with cryptographic agility and modular threat mitigation from inception.

Industry leaders, too, acknowledge the tension between innovation and stability. At the 2024 RSA Conference, Cisco's Chief Architect, David Uthels, noted: 'We're investing heavily in programmable protocols—SDN, iSQL—so networks adapt dynamically. But change must be cautious; the internet's strength lies in its stability, not radical disruption.'
