It interrogates how his philosophy challenges foundationalist assumptions about meaning, exposes the embeddedness of ethics in practice, and anticipates contemporary debates on pluralism, authenticity, and epistemic justice.

The Early Wittgenstein: Logical Atomism and the Crisis of Representation

In the **Tractatus**, Wittgenstein posits a world structured by logical form, where propositions mirror atomic facts through a one-to-one correspondence between language and reality. This picture theory assumes a universal, objective semantics—an ontology where meaning is fixed, truth is determinate, and value is suspended in a domain beyond empirical verification. Yet even in this early phase, fissures emerge. The **Tractatus**'s prohibition of “nonsense”—including ethical and aesthetic discourse—reveals a cultural silencing: values are excluded not because they lack weight, but because they resist logical codification. This reflects the early 20th-century faith in scientific rationalism, shaped by Einstein's relativity, the rise of analytic philosophy, and the trauma of World War I, which shattered Enlightenment certainties but left a void in meaning-making.

Yet within this apparent rigidity lies a latent recognition of context. The **Tractatus**'s last proposition—“Whereof one cannot speak, thereof one must be silent”—implies a cultural boundary: language has limits, and values, though real, must be acknowledged as irreducible to propositions. This silence, however, is not neutral. It reflects a Eurocentric epistemic posture: a rejection of myth, ritual, and non-Western modes of expression as “unscientific.” The very act of demarcation is itself a cultural valuation—what counts as rational, meaningful, or worthy of discourse is shaped by historical power structures. Wittgenstein's early logic thus encodes a cultural

bias, privileging transparency, clarity, and detachment—ideals forged in the crucible of industrial modernity and colonial rationalism.

The Turn: From Logic to Life in the *Philosophical Investigations*

Wittgenstein's transition from the *Tractatus* to the *Philosophical Investigations* marks a seismic shift. No longer a blueprint for a perfect language, philosophy becomes a therapeutic excavation of confused usage. Language games emerge not as idealized constructs but as lived, embodied practices—mutually constitutive of social life and value systems. “Meaning is use,” he declares, reframing value not as abstract truth but as embedded in routine, ritual, and shared interpretation. A word like “game” no longer denotes a universal form but a multiplicity: a child's play, a strategic board contest, a religious rite—all operating under distinct rules, shaped by cultural norms and communal agreement.

This pragmatic turn destabilizes the Enlightenment hierarchy of reason over tradition, culture, or emotion. Values are no longer external to language but sedimented in it—expressed through idioms, gestures, and institutional forms. The *Investigations* thus align with anthropological insights of Clifford Geertz and Victor Turner, who emphasized thick description and liminality. When a community prays, teaches, or judges, it enacts a form of life where moral intuition and linguistic practice converge. Value, therefore, is not discovered but performed—woven into the fabric of daily existence. This reframing challenges the universalist ambitions of moral philosophy, exposing ethics as culturally situated and historically contingent.

Geopolitical and Economic Context: War, Modernity, and the Crisis of Authority

Wittgenstein's intellectual evolution cannot be divorced from the 20th century's upheavals. Born in Vienna in 1889, he came of age amid the Austro-Hungarian Empire's pluralism and decline, a polyglot space where German, Slavic, and Jewish cultures collided. The collapse of empires, the trauma of World War I, and the rise of totalitarian ideologies underscored the fragility of grand narratives—whether metaphysical, political, or moral. In this climate, Wittgenstein's rejection of fixed representations resonates as a philosophical resistance to dogma. When individuals construct personalized realities, the ground of shared experience dissolves. Ethical claims, once anchored in communal practice, now compete in a marketplace of narratives. His insistence on “seeing as” underscores the danger of interpretive isolation: without a common horizon of understanding, value becomes subjective, and culture risks fragmentation into isolated solipsisms. The challenge for contemporary society is to reclaim, not a fixed truth, but a dynamic, accountable practice of meaning-making—one that honors diversity while sustaining coherence.

Expert Perspectives: From Analytic Philosophy to Critical Theory

Philosophers and scholars across disciplines have grappled with Wittgenstein's legacy. P.F. Strawson, in **The Bounds of Sense**, framed his later work as a reorientation from metaphysics to the “pre-philosophical” background of experience—affirming culture as the matrix of meaning. Ludwig Landgram emphasized Wittgenstein's proto-hermeneutic insight: values are not external to language but emerge through its internal logic. Meanwhile, critical theorists like Jürgen Habermas extended this, arguing that communicative rationality depends on shared linguistic norms—conditions Wittgenstein identified but did not fully theorize. For Habermas, discourse ethics aligns with Wittgenstein's focus on use: valid norms are those accepted in inclusive, undistorted dialogue.

Feminist and postcolonial scholars, however, caution against neutrality. Maria Lugones and Gayatri Spivak argue that Wittgenstein's forms of life often presume a homogenized “public” that excludes marginalized voices. Colonial encounters, they note, were frequently normalized through linguistic imperialism—imposing one language's game on others, erasing alternative value systems. The **Investigations** thus demands critical supplementation: recognizing that forms of life are contested terrains, where power shapes what counts as rational, ethical, or meaningful. Critics accuse him of fostering relativism—if meaning is use, then all values are context-bound, and cross-cultural judgment becomes impossible. Yet this misreads him: his therapy is not endorsement but clarification. He seeks to dissolve

confusion, not justify dogma. The danger lies not in his philosophy per se, but in its selective appropriation—using “meaning is use” to dismiss uncomfortable truths as “nonsense,” or to legitimize dominant narratives as the only rational form.

In the digital age, this risk is amplified. Algorithmic systems, trained on particular linguistic data, reinforce narrow forms of life—filter bubbles, echo chambers, misinformation. When AI models internalize biased language games, they reproduce and scale cultural distortions. The absence of public criteria in machine learning mirrors Wittgenstein’s warning: without shared rules, meaning becomes opaque, value judgments opaque, and accountability elusive. Moreover, in polarized societies, competing forms of life clash not just intellectually but existentially. The erosion of a common linguistic horizon threatens social cohesion, fueling alienation and identity-based fragmentation.

Yet Wittgenstein offers a path forward. His notion of “seeing as” implies a capacity for revision—recognizing that one’s form of life is not absolute, but provisional. It demands humility: to listen not just to affirm, but to understand. In this, philosophy becomes a practice of care—attending to how others live, speak, and value, without collapsing difference into equivalence. The goal is not consensus, but mutual recognition within a pluralistic framework.

Geopolitical Parallels: Culture, Value, and the Global Order

Wittgenstein’s insights resonate beyond philosophy into global geopolitics. The post-Cold War order, built on liberal universalism, assumed shared values—democracy, human rights, free markets—expressible through common language. But rising authoritarianism, populism, and cultural nationalism reveal the limits of this model. In China, “socialism with Chinese characteristics” blends Confucian ethics with Marxist-Leninist form; in Turkey, Erdoğan’s regime reconfigures Islamic tradition through state rhetoric. These systems are not mere deviations but distinct forms of life, articulated through unique linguistic games.

Wittgenstein teaches that coercion to impose one game undermines its very possibility. Instead, engagement requires understanding the internal logic of others’ practices. Yet this does not imply moral equivalence. The ethical imperative lies in fostering spaces where diverse forms of life can coexist, negotiate, and evolve. International institutions, education, and civil society must become laboratories of linguistic and cultural experimentation—sites where pluralism is not just tolerated but cultivated. The future of global order depends not on homogenization, but on the capacity to navigate difference with depth and respect.

Long-Term Implications and Strategic Insight

Looking ahead, Wittgenstein’s legacy shapes how we confront the next frontier: artificial intelligence and post-human cognition. As machines learn language, they inherit the biases and cultural game structures embedded in data. Without a critical awareness of language games, AI risks automating dominant narratives, silencing minority voices, and eroding the very possibility of pluralistic meaning. The challenge is to design systems that recognize, rather than replicate, linguistic diversity—systems that see as humans do: with sensitivity to context, nuance, and shared practice.

Education, too, must evolve. Traditional curricula often prioritize abstract knowledge over lived linguistic competence. A Wittgensteinian pedagogy emphasizes dialogue, critical listening, and practice—teaching students not just facts, but how to engage with others’ forms of life. This fosters not conformity, but capacity for reflection, adaptation, and ethical responsibility. In a world of rapid change, such skills are not optional—they are

essential for democratic resilience.

Economically, the shift toward care economies, cooperative models, and localized production reflects a revaluation of practice over profit—aligning with Wittgenstein’s insight that value is lived, not abstract. These trends suggest a future where economic systems are embedded in meaningful social practices, rather than abstract models. The strategic insight is clear: sustainable progress depends not on imposing universal formulas, but on nurturing the conditions for diverse, dynamic forms of life to thrive.

Conclusion: Culture, Value, and the Ongoing Inquiry

Wittgenstein’s journey from the *Tractatus* to the *Investigations* charts a profound transformation in how we understand culture and value. From a rigid, representational logic to a fluid, practice-based ontology, his work reveals that meaning is not discovered but enacted—woven into the fabric of daily life, shaped by history, power, and shared habit. In an age of fragmentation, digital overload, and ideological conflict, his philosophy offers a vital antidote: attention to use, humility toward context, and respect for the multiplicity of lifeworlds.

Yet this is not an endpoint. Wittgenstein’s inquiry is perpetual—each language game reveals new boundaries, each encounter invites revision. The culture and value systems we inherit are not fixed, but living: they demand continuous interpretation, negotiation, and care. As global forces reshape identity, economy, and truth, his legacy urges us not to retreat into dogma or nihilism, but to engage with the complexity of human meaning-making with clarity, courage, and compassion. In doing so, we honor not only Wittgenstein’s vision,
