The industry's scale was staggering: at its peak, over 100 sawmills operated along the Chattahoochee, felling an estimated 15 million trees by 1920. This extraction was enabled by engineering feats: log rafts floated downstream to processing hubs, while portages and tramways sliced through the labyrinth. But the environmental cost was immediate. Drainage ditches carved through peat soils increased oxidation, accelerating subsidence and carbon release. Fire suppression, initially intended to protect logs, disrupted natural fire

Beyond state lines, the ACF basin ties the Okefenokee to broader regional dependencies. Alabama, too, claims rights to Chattahoochee waters, complicating interstate negotiations. These disputes reflect a growing awareness that wetlands like the Okefenokee are not isolated ecosystems but nodes in vast hydrological networks, where upstream decisions ripple across state boundaries and ecological zones. The U.S. Army Corps of Engineers, tasked with balancing flood control, navigation, and environmental protection, faces mounting pressure to integrate climate projections into water management. Rising temperatures and shifting precipitation patterns threaten to intensify droughts and floods, demanding adaptive strategies that transcend political boundaries.
