By aligning military campaigns with economic policy, he transformed warfare into a tool of state-building—a revolutionary approach in an age dominated by feudal warlordism.

The Evolution of Strategy: From Guerilla Warrior to State Architect

Shivaji's military genius lay not in sheer numbers, but in asymmetric warfare tailored to the Deccan's rugged terrain and socio-political fabric. The Maratha **ganimi kava**—literally “war of the people”—leveraged mobility, local knowledge, and psychological warfare against larger, slower imperial forces. His raids on Bijapuri and Mughal supply lines disrupted enemy logistics while rallying local chieftains, merchants, and peasants who saw in him a defender of their rights against distant tyrants. Yet, by the 1660s, Shivaji's ambitions transcended hit-and-run tactics. The 1664 raid on Surat—then the wealthiest city in India and a Mughal revenue hub—was a turning point. Though framed as retaliation for Mughal-backed raids on Maratha territory, it was also a calculated strike against the economic lifeblood of the empire. The plunder, estimated in millions of rupees, funded his navy's expansion and solidified his reputation as a sovereign capable of challenging imperial might. His fleet, built from converted merchant vessels and local shipwrights along the Konkan coast, challenged Mughal naval dominance and secured coastal trade against European and pirate threats. Diplomatically, Shivaji navigated a treacherous web. He signed treaties with the Portuguese to secure arms and naval support, yet rebuffed their attempts to establish permanent bases. He engaged with the English East India Company initially as an ally, but

quickly recognized their imperial ambitions and confined them to coastal enclaves. His 1665 *Pune Treaty* with Aurangzeb—brokered after a temporary surrender—was a masterstroke of realpolitik: it secured recognition of his sovereignty while buying time to consolidate.
