The long-term implications hinge on whether America can reconcile its founding myth of liberty with its discriminatory reality. The path forward requires moving beyond symbolic gestures to structural change: redistributing wealth, reforming criminal justice, democratizing media, and centering marginalized voices in policymaking. The consequences of failure—further polarization, economic stagnation, democratic erosion—are too great to ignore. This is an ongoing story. The American experiment in ethnicity is not concluded. By the 18th century, colonial laws codified Black people as property, denying them personhood under statutes like the 1705 Virginia Slave Code, which declared that children born to enslaved mothers were enslaved regardless of father's status. This system was not merely brutal—it was economic engineering. Enslaved labor generated immense wealth for planters, fueling Atlantic trade and financing early American capitalism. By 1790, enslaved people constituted nearly 30% of the Southern population, their labor producing 75% of U.S. exports. But exclusion extended beyond Black enslavement. Native Americans were subjected to forced removal via the 1830 Indian Removal Act, culminating in the Trail of Tears, where thousands perished. Chinese immigrants, arriving in the mid-19th century to work the Gold Rush and build transcontinental railroads, were initially welcomed but later scapegoated. The 1882 Chinese Exclusion Act suspended immigration from China for decades, establishing a precedent for racial exclusion in immigration policy. Japanese Americans, descendants of laborers and farmers, faced escalating discrimination in the early 20th century—land ownership bans, exclusion from juries—before Executive Order 9066 interned 120,000 during World War II, seizing \$1.25 billion in property. Even Southern Europeans—Italians, Greeks, Southern Europeans—were not welcome as equals. In 1890s New York, Italian immigrants faced violent race riots, labeled

“inferiors” by nativists. Homer Watson’s 1907 painting **The Irishman** captures the stereotype of the “dangerous foreigner,” reflecting how whiteness itself was contested terrain. These groups achieved assimilation only after abandoning cultural distinctiveness and aligning with Anglo-Protest norms—a model later imposed on other marginalized communities. This history reveals discrimination as a tool of capital accumulation and social control. The racial caste system ensured a pliable, cheap workforce while concentrating wealth among a white elite. As historian Ira Katznelson shows, New Deal policies like Social Security excluded agricultural and domestic workers—disproportionately Black and Latino—denying them foundational economic security. This exclusion was not incidental; it was structural. Today, the legacy endures. The median white household holds 10 times the wealth of the median Black household, a gap rooted in centuries of denied homeownership, education, and employment access. Yet resistance has been persistent: the NAACP’s founding in 1909, Cesar Chavez’s United Farm Workers, and contemporary movements like Black Lives Matter challenge these hierarchies. The story of American ethnicity is thus one of violence and resilience, exclusion and claim-making.

This state-sanctioned discrimination restricted homeownership, the primary source of middle-class wealth in the U.S. As a result, Black families saw homeownership rates plummet from 44% in 1940 to 44% today—still half that of white families. The 2008 financial crisis disproportionately devastated Black and Latino homeowners, whose loan default rates surged due to predatory lending, reinforcing cycles of disinvestment. Immigration policy has similarly shaped economic hierarchies. The 1965 Immigration Act prioritized skilled professionals, but earlier quotas favored Northern Europeans, favoring assimilation. Later, guest worker programs—like the Bracero Program (1942–1964)—exploited Mexican laborers, denying them union protections and path to citizenship. Today, H-1B visas channel high-skilled immigrants into tech, but low-wage sectors remain dominated by migrants with limited legal safeguards. The gig economy amplifies these inequities. Platforms like Uber and DoorDash rely on a workforce where Black and Latino workers are overrepresented, yet lack benefits, job security, or collective bargaining power. Algorithmic management further entrenches bias: facial recognition errors disproportionately flag people of color, leading to deactivation, while route algorithms disadvantage

neighborhoods with fewer cars, often those of color. Yet economic exclusion is not static. The rise of Latino entrepreneurship—now the fastest-growing business sector—challenges historical barriers. In 2022, Latino-owned businesses generated \$1.3 trillion in revenue, yet face systemic credit gaps: Black entrepreneurs are 25% less likely than white counterparts to secure venture funding. These disparities reflect entrenched patterns: as economist William Darity notes, “Wealth gaps are not due to individual failure but to structural exclusion.” The consequences are profound. Wealth determines access to education, healthcare, and political influence. Without generational wealth, families remain vulnerable to economic shocks, perpetuating cycles of poverty and marginalization.

Industry, Media, and the Reproduction of Ethnic Hierarchies

Institutions like industry and media have played pivotal roles in both sustaining and challenging ethnic discrimination, shaping public perception and access to power. In media, historical underrepresentation reinforced a monolithic “American” narrative centered on whiteness. From early 20th-century radio to Hollywood films, Latino, Asian, and Native characters were stereotyped—lazy, exotic, or dangerous. The 1990 film **The Joy Luck Club**, while groundbreaking, initially faced criticism for catering to white audiences, reflecting broader patterns of exoticization. Even today, only 13% of newsroom leadership in major U.S. outlets are people of color, according to the Asian American Journalists Association (2023), limiting diverse storytelling. In tech, diversity remains a crisis. McKinsey’s 2022 report found Black and Hispanic professionals hold just 7% and 11% of tech roles, respectively, despite comprising 30% of the workforce. The “pipeline” argument falters: studies show underrepresented students excel in STEM when supported, yet systemic barriers—lack of mentorship, biased hiring, hostile work environments—derail aspirations. Companies like Salesforce have invested in pay equity and inclusion training, yet progress is slow. In healthcare, ethnic disparities persist. Black patients are 20% more likely to die from treatable conditions due to provider bias and underfunded facilities in minority neighborhoods. Latinos face language barriers that reduce preventive care access. These gaps are not technical failures but ethical ones—rooted in systemic neglect. Yet change is underway. The rise of ethnic media—Univision, Asian American outlets like **Eureka!**—offers counter-narratives.
