The 2019 inclusion of direct oral anticoagulants (DOACs) like apixaban and rivaroxaban—drugs developed with billions in U.S. R&D investment and marketed through aggressive physician education—reflects not only clinical efficacy but also commercial timing. Cheat sheets that prioritize these agents reinforce a cycle where educational focus amplifies pharmaceutical demand. Moreover, the global reach of the NCLEX—used as a licensure benchmark in over 40 countries through international testing partnerships—extends this influence beyond U.S. borders. In emerging economies, where local regulatory agencies may adopt FDA-style frameworks, pharmacology content modeled on the NCLEX becomes a de facto global standard. This has sparked debates about epistemic sovereignty: does reliance on a U.S.-centric pharmacology curriculum risk marginalizing regionally relevant disease patterns, such as tropical pharmacology or high-burden infectious diseases?
